Interim President: Nothing to Report

Traveling Baseball Director: Traveling baseball registrations need to be rescheduled. Registration will be held on August 14th from 6-7 pm.

Treasurer: The refund to a softball parent was sent. For the spotlight game a generator was rented and Katie requested to be reimbursed for the amount of \$57.50. Rich made a motion to reimburse Katie in the amount of \$57.50. Donny seconded. Motion carries on a voice vote. A hardship was requested for soccer registration. Katie sent pictures for the baseball and softball tournaments to the bulletin. Baseball info appeared in the paper but softball didn't.

Softball Director: Rich reported that the girl's teams had a great season and that all equipment needs to be turned in. They need bats for the upcoming season.

Soccer Director: Another registration day is needed. A registration will be held on August 14th from 6-7 pm. The 7/8 year-old boys team needs a player and the 12-13U team needs a minimum of 6 for a full team. A request was made for two hardships for a family. Rich made a motion to offer half of a hardship for each. It was seconded by Katie. The motion passes on a voice vote. Games will start after Labor Day. The city wants to get rid of the extra soccer nets if we don't need them. They are storing a lot of extras that we don't typically use. The city will take the baseball score board down. The umpire equipment needs to be taken out of the boxes, but the bases can be left in. Abdella needs to be flattened for use next year.

Communications Coordinator: There is a lot to be updated on the website. A decision to register online through NGIN was suggested and will now be an option for future registrations. Katie will look into Amazon Smile.

Events Coordinator: Sunday is the game at the Saints. For tickets, Tyson Jeffrey's can be called. The Theme for this year's float for Heritage Days is Tree of Growth/SPP Strong. Decorating will take place on Friday, Aug. 15 at 6 and finishing touches can be made on Saturday. Kids will arrive at 10 and are encouraged to wear SPP gear. A motion to budget for and not to exceed \$400 for candy and decorations for the parade was made by Katie and seconded by Donny. Motion passes on a voice vote.
