

Roseau Youth Hockey Disciplinary Policy

As of November 1, 2014 the Roseau Youth Hockey (RYH) facility will be under 24 hour surveillance. As a result of vandalism and damage to our North Rink facility the following policy will be put into place effective November 1, 2014.

Any violation of rules deemed as vandalism, bullying, or otherwise inappropriate behavior may be documented and reviewed by the RYH Disciplinary Committee. If the infraction is criminal in nature and/or involves an adult(s) the matter may be turned over to the appropriate authorities. For youth members of the RYH association or community members using the RYH North Rink facility the following disciplinary process will be followed.

- Infractions may be turned into a RYH Board Member.
- The board member shall provide the infraction information to the RYH Disciplinary Committee.
- The Disciplinary Committee will review all available information including but not limited to video camera footage, interviews of the party or parties involved, and / or witnesses. The RYH Disciplinary Committee will document and date all pertinent information that will be given to the RYH board.
- If the RYH Disciplinary Committee deems action should be taken, the following rules will apply and the RYH Disciplinary Committee will set the start and end dates of disciplinary action.
- The RYH Disciplinary Committee will contact the parents and/or parties involved to set up a discussion and notification of disciplinary action.

1st Offense – A RYH player will miss the next scheduled practice and will not be allowed in the North Rink Facility for a 24 hour period. If not a RYH player that individual will not be allowed in the North Rink facility for a 24 hour period.

2nd Offense – A RYH player will miss 1 full week of scheduled practices and all games within that 7 day period. If not a RYH player that individual will not be allowed in the North Rink facility for 7 days.

3rd Offense – A RYH player will be suspended from any and all RYH functions for 14 days. If not a RYH player that individual will be suspended from the RYH North Rink facility for 14 days.

4th Offense – A RYH player will be removed from the Roseau Youth Hockey program for the remainder of the season and not allowed into the North Rink facility for the remainder of the season. If not a RYH player that individual will be not be allowed into the North Rink Facility for the remainder of the hockey season.

If disciplinary actions are not strictly adhered to that individual may be suspended immediately from the program and suspended from the use of the Roseau Youth Hockey North Rink Facility.

If a violation of the rules involves a RYH member, while representing RYH at another facility, the same rules apply.

If an individual is a repeat offender in consecutive years, RYH reserves the right to immediately suspend an individual from RYH or the RYH North Rink Facility regardless of the offense ladder listed above.

In any case, the RYH Discipline Committee reserves the right to suspend a RYH member from RYH Hockey.

In any case, the RYH Discipline Committee reserves the right to follow their procedure, which may include restitution for damages, and turn over the violation to the authorities based on the severity of the violation.

Signature required: Players will not be to participate in RYH activities until this form is signed, dated, and returned to the team coach or manager.
