Terms of positions

Ben and Chet - three years, term ending in 2017 Derek and Eric - two years, term ending in 2016 Marhsall and Theresa - 1 year, term ending in 2015

Each term is three years in length, but president, vice-president and treasurer will be voted upon each year.
