Concussion: Becky has been working with TC and Michael Schoeneman on concussion testing. TC mentioned it is best to put all kids from various associations, under one umbrella so that access to the testing is easier to track. Many associations (gymnastics, soccer, lacrosse, hockey, baseball, basketball, Kids First???) are already interested. The problem is how do we fund it? (\$1.50-\$2.50 per test) Becky contacted Federated to see if they would pay \$1000 to get this going this year and then figure out future funding. Julie R. said money must go to 503C association.
