## **Facility Use Terms & Agreement**

#### **APPLICATION INSTRUCTIONS:**

Please carefully read all of the terms of use and fee's. At the end of page 2 there is an area for you to initial. By initialing you are indicating that you understand and agree to abide by the terms of use set forth in this agreement.

#### APPLICATION:

Submit application and a \$40.00 application fee to Junction City Athletics at P.O Box 151 Junction City, Ore 97448 to reserve a date and site. If your desired date is unavailable the application fee is refundable.

#### **INSURANCE:**

Applicants are required to provide for each event a certificate of insurance and an additional insured endorsement naming Junction City Athletics and Junction City School Dist #69 as additionally insured under the insurance policy. The endorsement shall also state that the applicants event insurance is primary over any and all other insurance coverage. Insurance certificate is due no later than 3 weeks prior to the event.

#### **BALL FIELD MAINTENANCE:**

The initial field prep, lining, watering and dragging of the field will be provided by JCA staff each day of your tournament. If you desire maintenance between games you may either do it yourself or request JCA provide a maintenance crew for you event if available. If you choose to do field maintenance yourself JCA will provide you with field rakes and a chalk box and trash can liners and toilet paper for restrooms. Chalk is available for a fee per bag.

#### CONCESSIONS:

Concession staff availability will be determined after application is made. If the concession staff is available JCA will provide concessions for your event and the concession stand will be open 1 half hour prior to the start of your first game each day Saturday / Sunday. Concessions may or may not be available Mon-Fri. If JCA is available to operate concessions then no outside concessionaires will be allowed period. If the Concession staff is unavailable the stand itself is not available for use. There will be no sharing / split of concession revenues.

#### **EVENT SCHEDULING:**

Games can start at 8:30 a.m. Saturday and 8:00 a.m. Sunday mornings.

#### **EVENT PARKING:**

Your help is needed in controlling the parking lot off of Rose St. Please be aware that parking on Oak St is by permit only and event participants will be subject to parking fines. <u>Over night parking / Camping is allowed on a case by case basis if teams are traveling further than 45 min to Junction city.</u>

#### **TOURNAMENT SCHEDULE:**

The tournament schedule / brackets must be submitted to JCA no later 72hrs before your event.

#### **RAIN OUTS:**

JCA will make every reasonable effort to assist you to get your event completed. However, JCA reserves the right to delay, postpone reschedule or cancel event due to field and weather conditions. In the case of a cancelled event JCA will refund all applicable deposits minus any materials used.

#### **TOBACCO & ALCOHOLIC BEVERAGES:**

Tobacco & alcoholic beverages are not allowed on the facility (This includes the parking lot) before, during and after your event. Tournament directors are responsible for strictly enforcing this policy. Violation of this policy will result in the forfeiture of any and all deposits and up to and including the cancellation of the remainder of the event.

#### **MOTORIZED VEHICLE USE:**

Only authorized vehicles are permitted on Laurel Sports complex. If you are renting the complex and you elect to provide your own field maintenance then 1 personal utility vehicle, gas or electric, will be allowed for the purposes of transporting event supplies to and from parking areas and for the transport of the physically disabled. At no time will minors be permitted to operate the vehicle. It is the Tournament director's responsibility to enforce this rule. Failure to comply will result in the forfeiture of all deposits.

#### **PRIORITY USE:**

Field use for practices for JCA teams and non JCA teams paying a facility use fee is on a first come – first served basis. JCA's policy requires coaches to work together when several teams are practicing at the same time. It is incumbent that all users work together. If conflicts arise because coaches failed to work together teams may forfeit their right to use the facility at the sole discretion of JCA Board of directors.

Priority use is as follows.

- 1. Scheduled Games or Tournaments.
- 2. In Season Team Practices.
- 3. Other events

For information about scheduled events at Laurel Sports Complex please consult the field master calendar at www.junctioncityathletics.com under the JCA Facilities menu tab.

#### FIELD USE RULES:

Teams are welcome to use the facility, as they need however here are some basic guidelines.

- 1. Fields that are dragged and lined are not available.
- 2. Fields that are wet and muddy are not available for use. Common sense must be used.
- 3. Do not hit hard balls into cyclone fencing.
- 4. Equipment used from the equipment cache must be returned to the closet and cleaned.
- 5. Please clean up any litter from your use.
- 6. For tournament rentals It is the responsibility of the group renting Laurel Sports Complex to do a final walk through to clean up miscellaneous garbage on the fields, dugouts and parking lot.

#### FEES/SERVICES:

Application fee: \$40.00-Non-Refundable - Applicable to weekday or weekend events.

\*Refundable Deposit: \$300 Due 3 weeks before event date.

\*Initial Field Preparation: \$25.00 per field per day (\$50.00 minimum) includes 2 bags chalk.

\*Field maintenance fee: \$8.00 per hr /per field
Tournament Field Rental Fee \$15.00 per game / per field

Practice Field Rental \$10 per hr-Renter must abide by field use rules.

Soccer / Football Field \$25 per hour per field

\*Team Facility Use Fee \$25 per player per team. Teams must abide by field use rules.

Individual game fee \$50 per game. Includes field prep. Does not include Umpire or game Balls

Bag Of Chalk \$8.50 per bag Turface / Infield Dryer \$12.50 Bag

Chemical Toilet Service \$35 per unit- Charges if applicable will be determined by JCA Staff. Foul Line Painting \$35 per field-Optional. However, no outside painting will be allowed.

Home Run Fencing \$50 Per Field.-If fencing needs to be installed.

<sup>\*</sup>Initial Field Preparation. JCA staff will perform initial Field Prep. This includes dragging, chalking and deep watering in preparation of the event. This is mandatory for all Baseball and Softball tournament events.

<sup>\*</sup>Field maintenance fee includes labor, chalking fields, watering, dragging fields, equipment and fuel, maintaining toilets and emptying of garbage cans as needed during event. Time starts at the start of your first game and concludes one ½ hour after the end of the last games. Additional special request must be made in writing 2 weeks prior to event for review by JCA staff. Additional charges may apply.

<sup>\*</sup> Team Facility Use Fee. This fee is in lue of an hourly rental fee for non JCA registered teams. It covers the cost's associated with normal use of practices and the associated cost of games scheduled by Junction City Athletics. Teams are expected to abide by the priority use and field usage rules for Laurel Sports Complex. Each application Is reveiwed and approved by JCA staff.
