## **Dues & Sponsorship Policy Talking Points**

- 1. Sponsorship form has been updated
  - a. Player or Parent must fill out the "WYHA Member Information" section of the sponsorship form prior to giving the form to the sponsor
  - b. Sponsor needs to completely fill out sponsorship form
  - c. Sponsor needs to make a copy of the filled out sponsorship form
  - d. Sponsor returns the form and sponsorship money to the family personally or at the address provided in the "WYHA Member Information"
  - e. Sponsorships are due to the family Oct 18th
  - f. Family is responsible for collecting any and all sponsorship forms
  - g. Family organizes all Peelers, Sponsorships, and Cash accordingly to cover the current year's dues
  - h. Family responsible for providing the treasurer all of the collected money and unsold peelers in an envelope by the due date
  - i. There will be 2 collection nights
  - j. Dues are due November 1, 2023.
