The Seton Volleyball Championships benefit The Waukesha County Catholic Schools Tuition Assistance Fund, which is used to make Catholic school education a real possibility for those elementary students who may not otherwise be able to afford full tuition. Tuition assistance is provided in the form of \$1,000 grants, paid directly to your child's school on your behalf.

## In order to process your application, we require the following:

- That you have been a member of good standing at your parish for a minimum of 6 months.
- That your family regularly worships with your parish community.
- That you commit a portion of your time to serve in one or more school/parish ministry areas.
- That you provide us with a copy of your most recent Federal Income Tax Return Form 1040.
- That you have submitted a completed application on or before the deadline.
- That your children must attend a Catholic Elementary School in Waukesha County for the year of assistance.
