TOURNAMENT RULES & INFORMATION

GAME FORMAT:

- *All Games are three (3) periods Stop Time
- *Squirt, Peewee and Bantam will have twelve (12) minute periods
- *Three (3) minute warm up period
- *Top two (2) teams with the most points will play in a Championship Game
- *Points awarded for these games are two (2) points for a victory, one (1) for a tie
- *Third (3rd) period will be a running time if a team is up by more than five (5) goals

GAME TIES:

*Non-Championship Games that end a tie after regulation will remain a tie

*Championship Game ties will continue with a five (5) player shootout

*If still tied after the five (5) player shootout, the game will be decided by a sudden death shootout.

TIES IN STANDINGS:

*In the event of ties in standings, the final result will be decided by the following:

1st - Head to Head Record

2nd – Least Amount of Penalty Minutes

3rd - Highest Goal Differential (Capped at 5 goals per Game)

4th - Least Goals Against (Capped at 5 goals per Game)

5th - Coin Toss

PENALTIES: *USA Hockey rules apply to all games played during the tournament

*Minor Penalties will be One Minute and Thirty Seconds (1:30)

*Major Penalties will be Five Minutes (5:00)

FIGHTING: *Automatic Tournament suspension

CHECK-IN: *All players must be USA Hockey Registered. Registration must be provided.
