- Financial report : Kevin Wood, report available upon request
 - Approval of mileage and meeting food: Motion made for mileage for hearings (one way @ 57.5 for hearings, drafts, playoffs, association meetings for District 6 Directors and two ways @57.5 for winter and summer meetings) Approved unanimously

- > STAR (Jill): posters to be handed out at September meeting


