Secretary's Report- Amy Klaiman: ESchindler made a motion to approve the July 13, 2015, meeting minutes. NBergeron seconded the motion. The motion passed unanimously.

President's Report- Greg Gibson: Bids for the Central Middle School locker room clock project have been completed. Motion to approve the installation of 6 locker room clocks at CMS for \$5,240.00 was made by ESchindler and seconded by NBergeron. The motion passed unanimously.

Last year at this time we had 53 teams registered. Edina will be hosting the Jr. Gold State Tournament this season. There is a possibility that WYHA will host Jr. Gold playdowns.

Registrar – Mark Sivets for Colleen Sivets: Registration is now open. Team names will be the same as last year. Registration for travel teams will close 2 weeks before tryouts in order to create the correct number of teams at each level.

Safesport – Greg Gibson: We are still looking for a new Safesport Coordinator.

BlueLine – Ruth Allen and Jerry Jensen: The volunteer hours policy of 12 hours per family will remain the same for the 2015-16 season. Survey results are currently being implemented. One change that will occur is a greater use of social media. Tria is going sponsor WYHA medical kits this year. Tria is also interested in partnering with WYHA to provide base line concussion testing for the players. A meeting was held with Fun2Raise company to provide advertising and sponsorship to WYHA. JJensen made a motion to create a relationship between Fun2Raise and WYHA. NBergeron seconded the motion and the motion passed unanimously. ESchindler made a motion to approve up to \$4,500.00 for Fun2Raise. This motion was seconded by BGardner and passed unanimously.

TNelko made a motion to approve \$45,000.00 to improve the goalie program. BGardner seconded the motion. The motion passed unanimously.
