Sports' Recaps

Softball

- Good.
- Tryouts are done, posted tryouts scores & gave transparency to the system
- Set up planning meeting for next year tryouts.
- Q: all happy? A: only 2 emails. All went well.
- Will review budget & next meeting will plan numbers
- Q: any jumps? A: Outside last season, not really as some are coming back from ERAA

Soccer

- Last day for Fall season;
- Gen meeting tomorrow w/elections at YSB;
- Budget process will have some changeover.
- Q: same winter training? A: yes Nov –April.
- Q: Space? A: Dome.

Football

- Finished season; It's a short, 9-week season went VERY well.
- One program 6th grade level had more wins than any metro east teams.
- Couple grade levels did well.
- Flag football went VERY well & had great feedback on expansion.
- EO-Season Tournament: witnessed better caliber playing & creativity.
- Not any complaints about coaches & parents from outside; some parents were not happy w/where their child placed.
- More of a CGAA counter season. Have 5 teams in tournament over MEA and then officially done Sunday
- Q: is Park success creating positive feelings overall? A: kids are more excited going to games general more excitement to be around program. Picked up 19 new kids from St Paul Park & New Port & will open communications. Helps Varsity having success. Continues believe PCA has impact, especially at 6th gr level.
- Q: Any concussion issues? A: Concussion rates were about [maybe] 5 w/over 400 players. Does not happen on 'big' hits. Focused on how to tackle w/out the head involved. Concussions occur more with head-to-ground contact. We had 4 to 5 players with injuries. The rest of Metro East has adapted to better tackling process & return-to-play practices, so, overall better.

Baseball

- Ouiet:
- 2016 Teams announced; feedback on transparency processes, but setting guidelines;
- Fall ball wrapping up teams playing Lamar;
- Adam Palodachek stepping down & Shane [InHouse Director] stepped into Travel Director spot;
- Want to develop nice athletes on & off field; A 10-level player noticed w/positive well behaved teams.
- Implementing evaluations before teams start; focusing on player retention & getting new players; identifying players who want to be there:
- Offer handbook to coaches:
- Tournament Team: Pull out team, and pull up team to avoid losing players to play in travel tournaments to avoid losing them.
- Q: found InHouse Director? A: Josh Monger stepped up. All board support for evaluation process.
- Borrowing Softball processes of using ½-1 hour practice time prior to game, then play game [shared time to develop teams]
- Turf costs: West rink to keep costs down; want to make sure divisions keep costs down & addressing time allotment. Dan recommends softball baseball & football to discuss time usage; discuss w/Zach to avoid commitment to too many hours, would like to avoid that situation. Maybe look to propose to Zach [Tim in charge] what 3 divisions would like to schedule, give West rink notice of time needed. Softball not the time commitment, but divisions are being charged same as outside. Maybe get reduced rate? Q: pass fee along to teams? A: no. Didn't get invoiced by city in June & received in July at end of sport season. Suggestion: put together usage and bring to Zach & discuss.
- Football liked the West Rink, but could get AC for \$5/hour vs \$90/hour. Dan Smoot has contacted West Rink to negotiate time & fee. Found out could get reduced rate w/short notice, as economics: lowered fee is more than \$0 fee charged. West Rink is used frequently by college teams for Lacrosse.

Hockey

- All is good'
- Tryouts finished today; teams get announced tonight by 9:00p.m. Was at rink all day. Made thru coach selection; [4] head coaches from 2 HS and CGAA help out w/coaching selection. All is just starting.
- Q: Processes get followed? A: Yes, they were followed. Discussion: "pool play" is not tryouts. What happened? Tryouts. Put into groups "A" and "B" pools, which offered youth play time. They were NOT intended to be tryouts, just gave any bubble kids opportunity to get further evaluation. Extra evaluation and not considered "tryouts". One thing done & all approved and wanted to push back time & Zach D. said cannot push back because time was allotted. Signed with city & can that agreement get changed? No, have a 10-year commitment. Hockey has to fill the time.
- Hockey vs. Football: Hockey pool is published and says, "...tryout is not pool..." Most complaint is about missing games & practices in football kids feel the pool is "mandatory" and cannot miss or will not make the team. Tryouts went well. Pool sessions were offered, but kids felt needed to go mandatory. Football doesn't want Hockey tryouts to occur simultaneously as Football looses players in such a short season. Football gets 2 weeks, then Hockey has clinics, tryouts and sessions that will interfere with play time.
- Next year will have expansion program & could play through Nov 1st at latest. Parents don't like to make those choices between Football or Hockey. Complaints are not answered by Hockey re: these issues. Football doesn't know what to do.
- Q: When is Hockey reasonable to expect conflict. When overlaps occur, is there a way to be more involved and say "optional" and will be treated as such. Q: Is Hockey receptive to resolution? Or Main discuses how it should be done & sit on ice bills and maybe a joint venture. Negotiate for simple solution. Bubble kids are in the hardest situation.
- Q: do most programs start this early? A: No, we started 1 week early. Tried to push time back, but Zach said, "No, commitment is made, you need to start when scheduled." Q: what would the cost loss if Hockey did what wanted to do? A: \$205/hour per sheet of ice. Won't meet again until November & then discuss timing issue.
- Another issue: kids don't have any energy when hockey tryouts/sessions and then nothing [energy] left for football. Will need to work together as positively as possible.
- Football is [9] weeks vs. Hockey [5] months. Try to offer a "choice' for kids. Q: how far out to push to avoid Football. A: Weekend before MEA and after completely done one week after. Q: Dan Smoot willing to go to Hockey meeting? A: Dan will call Charlie; Dan H willing to go. Reality is to personally interact and find time. Basketball scheduled around Football & encourages Football playtime, basketball can wait. If remove 8-10 days of pools/scrimmages then all will be fine. But w/10days kids feel they have to attend Hockey in lieu of FB. Next week, both sports will be in process. Dan H to talk to Charlie & see if he's flexible as basketball & baseball. Dan Smoot will keep fighting for FB time. Dan Smoot to work out w/hockey. Rink time costs for Hockey vs. FB places Hockey higher on pole.
- Hockey starts games in 10 days, so only have little time to prep for first game. Even holding off 1 week, that puts pressure on start time. That puts FB under player stress. Table until further notice on future communications.

Football

Volleyball

- Scheduling gym space big "monster"; Julie is to see Dave and Curt [been in contact] and still remains getting "leftover space"; need to sit down face-to-face and set time. Julie went through rec schedule & got time, but got remaining time later & players need time and will practice to 9:30 p.m.
- Consideration: better gym time or more practice time. JO coming up on 29th; older kids have tryouts until 11/16th due to HS volleyball.
- Hope not to cap team at 7 teams, hoping not to have to cut any players or teams.
- Dan H: talk to Dave because there is space & time available.
- To go outside is more expensive and keep place local.
- Monday 19th had space meeting; Dan H hasn't seen it Brad read &disagreed with it [Athletic Studies Study]. Cottage grove so far behind they think they're leading the pack regarding facilities available compared to other communities.

Positive Coaching Alliance

- Dan 'good life" experience: Runner in cross-country in 7th grade. Disabled athlete finishes at 39 minutes & team creates human tunnel for teammate to finish.
- Need to get games clinic scheduled & follow up with game meeting. Both before beginning of year.
- Dan will pick date & hope nothing going on. No perfect date/time.
- Basketball wants to go, so will avoid those dates; Hockey has poor attendance; Volleyball wants to attend & have coaches attend. Football coaches participated on-line & those coaches got a sport jacket. Once found out they could get a jacket, then they participated. If participate on line, need a key-code. Dan Smoot to send Jackie [Volleyball] the key-code. Take online version before attending, then will be more impactful. Volleyball Jackie wants to encourage VB coaches to do it.
- Dan would love to others to ask him to set though up for it love to do it.
