#### **Board of Directors Meeting**

F. Montgomery Brown was to present a training on Safe Sport, he was not present. VanRooyan tried calling and later received an email stating he thought the meeting was next Wednesday.

DeGroote presented to the board a slide show of his "TeamKonect" App for IPhones. (Droid System is coming out shortly) This application utilizes a calendar, roster tracker, instant messaging per team contacts (can be to players only, parents only, or all), player contacts if the player is older than 13. This program would be a great asset to team organizing. Kathy will distribute it to the older groups coaches to see if they have an interest in the program.

Honore Pittenger reported all coaches should have their USA hockey number and sent to her as soon as possible. She also reported that no one should be requesting Birth Certificates of past players. They have all been approved into the system and once approved we do not need to have them resend them. Only new skaters will need to supply birth certificates. Rosters need to be sent to Honore as soon as possible for approval before any travel tournaments take place. Roster editing deadline is December 30<sup>th</sup>.

Treasurers Report: McCune introduced Jason Tibbets (SYHA intern this season) McCune also reported that payments for registration have been entered, and those skaters with remaining balances have received an electronic statement. These statements will allow the parents to pay online. There is also a line on the current financial statement that states "Operating expenses", this will be edited with a line item to state "Rink Improvements" for clearer reporting. We have purchased 1500 flex tickets from SC Musketeers. Kirk Motioned for approval and seconded by Zaber.

**Registrar's report**: Honore reported that there are 194 skaters registered to date.

**Ice Scheduler:** The online calendar is up to date.

**Membership and Recruitment:** Kane reported that we are currently down from our goals for registration. We have 2 more registration dates: Sunday Sept 21, and Sunday Sept 28 form 4-6.
