City/Rink Relations: In November the city spent money to do updates. The Banner for public skating blew off. They are going to look at the cost to replace that. Learn to skate starts Sunday for the city session. They have had around 11 people signed up. There is going to be some reorganization of the departments. It is proposed that the IBP Ice Center will move over to the Parks and Rec department July 1st. Center Plate will take over the Convention Center. Lien stated that there should be no visible changes to the IBP Ice Center or SYHA with this change. They are still searching for a new-used Zamboni. They are looking to spend around \$50,000 and the last one that they came across was a 2006 for \$62,000. The roof will be replaced in the Spring as well as replacing the concrete in the front entryway.
