Referees:	Bantams are having issue with 3 referee system - with only one referee violations are getting missed, especially when that referee is younger and new to the role. The supporting referees aren't always mentoring when they should be. Opinion is that not as much gets missed with 2-man system. Referees get \$35 a game, linesman get \$25, so it's cheaper to run 2-man system. Mike Delong stated that the decision is at association level, but USA Hockey is pushing 3-man system. He also states one of the problems is that they lost 10% of officials in WI in last year. The intention is to schedule more experienced referees with the less experienced for mentoring purposes.			
Mite Double Roster:	Squirt B coach wants to roster all 7 mite boys and wants them at Squirt practice. Double rostered will be approved for 5 games and one practice a week. Those that want more can get more. Meeting will be held November 12 <sup>th</sup> about double rostering. If they want more than 5 games, it has to be approved by the board as that is what is what is stated by association guidelines. We also need to beware of burn-out in the double-rostered kids. Craig Campbell suggested they only get their 5 games so Squirt registered kids get appropriate ice time for development. Suggestion to take 2 at a time per game, not all 7, and for practice.			
Mite Move Up Procedure:	Discussed technique for moving kids up a level when attain certain skill level. Previously discussed moving up at one time during season, versus several times. Concern raised about not having final year mites practicing at Mite level to prepare them for Squirt level. Families are still asking about moving kids up at a certain level. LTS ends December 20th and a meeting will be scheduled to see who will continue in LPH. There are three 2007s at LPH level. Appears that LPH and Mites teach same or similar skills - difference is the 1/2 ice games versus cross-ice. Determine skill criteria for moving up now.			
Open Forum:	Bantam B are registered as 2b.			
	District 2 meeting – Bantam B2 game times are at 12 minute periods, or only one hour time slots. Where Bantam B1 is scheduled for 90 minutes. The thought is that B2 should be same at B1 as they are at the same level. Craig is going to bring up at next meeting.			
	Ice time – Request for Bantams to get more full-ice practice time. John will continue to work on December schedule and rotate practices for that.			
	Tournament Guidelines - Add a rule to require all team members to pay regardless of attendance - some players don't pay their portion if they aren't attending.			
	First aid kit - Bag donated by Bennis family. AED equipment is outdated - do we want to update? There is a question of if even having the AED creates too much liability for the association. Motion by Jesse Bohatta to authorize each team to get a first aid kit. Seconded by Brian Stevens. Jesse to check out kits on website and consult with Tonya Bennis to order for all teams.
