Girls' Coop Discussion: game allotments, tournament allotments, split all costs to the proportion of the number of players, game allowance for each level, ref pay, fair and equitable concerns (equal opportunity for boys and girls-game totals at each level) Owatonna is paying 60% of the jersey cost. Owatonna is paying 60% of the sock cost. This will be paid out of the player development fund. Girls' jerseys for next year should come out of the equipment budget just like the other OYHA jerseys

Education & Development Committee:

Try Hockey for free is coming together, but there is some concern about where registrations are going. All players who sign up for try hockey for free get in free to the boys' high school game on that afternoon. Is there a waiver of liability? This is a sanctioned event.

Concerns about the evaluation process from parents and coaches discussed. Ed and Development is recommending try-outs be done by outside evaluators. Observations would be done during 2 time slots for each level, and would include skills and drills, cross ice or half ice, and goalie evaluations. Bantams and peewees would be done at the same time, and Squirts and girls would be done at the same time. Team meetings to follow.

The board is seeking a coaching coordinator who will begin the position January 1 and run through December 31.

Next year there will need to be a hockey development coordinator.

Brad Meier (4 Peewee teams and U10s), Brad Vogt and Jeff Gryniewski (Squirts) Adam Buegler (Bantams) are going to work with the goalies for each team once a week.

Any players who sign up for Try Hockey for Free can participate in Park and Rec for the rest of session 1, free of charge for registration. They will need to rent equipment if needed.
