- Balance \$566,683.00
- P&L 38K more; \$4,824 less than last year. Right on budget, off \$400+
- MSP Kim DeVaan, Dave Blumberg, Motion to pay expenses NOT TO exceed \$2,500.00, No discussion, Passed.
- MSP Kim DeVaan, Tim Kaplan. Motion to pay Russell & Associates for portion of bill, total \$9,000.000. No discussion. Passed.
- Talked to auditor, response is "things looked well, CGAA is getting better." Improvements: timeliness; need better at matching GL accounts.
- Will set up Treasurer meeting for Jan 2016.
- Q: [boy] in hospital immune deficiency disorder, 8yrs old. Family has been with CGAA for a long time & involved. Does CGAA want to do anything? A: Kim to send out email to divisions, requesting help. Q: Volleyball paid \$250.

- MSP Mary Perren, Dave Blumberg. Motion to Pay City of Newport \$334.89 for 10% profit contribution. No discussion. Passed

Basketball [per DAN H]

- Had a parent complaint. Issue of playing start/time issues w/coach; no kids brought in; parent called & stated "coach yelled at kids". Per coach the kids were not behaving, specific daughter was "quitting" and posting; Ok with CGAA; Parent didn't like solution; CGAA Ok with player quitting & moving to ERAA; Parent Ok in the end. Result: was best for player quit & moved.
- FYI: always support the coach. [per DAVE] two things to know and accept: do not want kids to quit and never use the words 'winning' and 'losing' during game play-time.
- Travel off & running and otherwise running smoothly.

Soccer: [Kevin Valento]

- Hired Director of Coaching: Jerry Handler from Augsburg College.
- Can't wait for him to start.
- Q: Are his coach fees in budget? A: Yes. He's under independent contractor status. Q: Is his information on file? A: No, need to get that to Tina.

Hockey [Chris Rudh]

- Going to hold our biggest fundraiser in February, Mary Perren is on task.
- Q: jersey [Indian] issues with hockey, where is that issue at? A: talked with Charlie about it & going forward, talked to coach and referred, "... not the best move, regardless of heritage..." it's a "big no-no", CGAA does not support any deviation from Division jersey. Hockey Board said, "Ok, but if it's a problem, then can't do it."
- Historically, Divisions have teams that take ownership on secondary jerseys and usually not a problem, but only if causes issues, then Main Board advises, "No."

Baseball [Tim Kaplan]

- Arena opens March 5th
- May have U16 baseball team starting recruiting out of 10th grade; went over rules. VFW [McGowan] gets first choice on players, then CGAA gets to make a competitive team. Board gets final approval.
- Q: using Winter AC space? A: Not yet. Coach McGowan going to work with kids fundamentals.
