- Good Fall season still progressing to finish
- Winter officially begins Tuesday [11/10/15] 1st girls hockey game this week
- Swimming Sections [girls] this week
- Coach Darin [Park HS Football] Looked at Coaching Alliance and similar to Park's program of "Why Do You Coach?" program – good connection. Discuss in monthly coach meeting to be a positive role model for kids, esp. those who lack that in their lives and teach them about attitude and effort – the two things they can control everyday.
- Coach D continued: Fall brief update includes 6-game winning season [hasn't happened since 1999]. Thanks to fact been put in 5A vs 6A – big change and playing against different teams. Where Park HS football program needs to be. Loss vs. St. Thomas wasn't significant, so PHS very close to top teir teams. South St Paul, PHS beat by [1] and great game, they're in State Championship team at 4A. Good competition, players performed well, proud of them. Two players signing letter of intent, have received Division 1 offeres – great for them – great for program and school.
- Partner with CGAA, Dan Smoot gaining greater interest for the sport through CGAA. Transitioning 7<sup>th</sup> & 8<sup>th</sup> grades into out Jr Wolfpack - Justin [Langhben] coaching & did a great job. Making transition into program this next year. Partner in running Golf Tournament fundraiser every year & brings everybody together & think doing a good job there. CGAA helps with youth clinics as well in the spring and work is appreciated.

New Business: none

### President: Dan Harrison

- MSP Dan Harrison, Mary Perren. Signed audit bill \$18,000.00 annually for 1099 engagement letter with Russell & Associates for our audit. Discussion: Q: does that get open for bids? A: Haven't yet, but want to try that next year. We are a better looking client, now, with a clean opinion and we're reasonable client, Russell & Associates [Ryan] looks out for us and has taken care of us, but we need to see who else is out there. We can make our future choices with confidence, maybe a 3year cycle. May not guarantee a switch, but prevents over-billing. Definitely something on the "radar" for next year.
- Reminder background checks on coaches Main Board should perform a background check again. Q: does coaches need a background check every year? The school district doesn't require that. A: Yes. CGAA has policy to perform every year, it's a code – it's free for them to request it. If they coach multiple sports only need to request once. Will send the code out for CGAA website.
- Hazing activities. Brought up to CGAA's attention, reminder to coaches; not have "silly" activities that resemble hazing. Make sure it doesn't happen in your division. Strongly to recommend to remove the coach from position.
- Christmas meeting: 12.13.15 move off-site to one of our gambling locations with happy-hour prior with appetizers. Should have funds available. All in favor, so will meet at 5:30 p.m. at Clover Leaf in back area. Mary: gambling cannot pay for alcohol, so can transfer funds to general account, \$1,000.00. MSP Dan Harrison, Brad Strom. Motion Gambling transfers \$1,000.00 to general fund. No discussion. Passed
- MSP Dan Harrison Dave Blumberg Motion to move meeting to Clove Leaf location No discussion Passed

- Bonuses. 3 items. Once past revenue audit: passed w/out any adjustments. Good. Auditor was present and kept things moving along.
  - 1 issue audit result: found 3 games not accounted for [not include funds]: apparently they went missing [lost] may have consequences. Due Diligence: decided to spot check if was an isolated incident will pay auditors extra \$400.00 to double check inventory.
  - 2 issue: haven't done anything re: payroll increase of employees. Business is better. Don't wish to give a "raise", but was discussing w/Justin Langbehn to offer bonuses as "thank you for hard work and expanding business". Bonuses ranging \$3-3,500.00 total for all Gambling employees. Thoughts against? Q: money from Gambling? A: funds from payroll, through profits. Concern the discrepancy between hourly employees and Mary/Tina wages. Feel that \$2,000.00 is substantial, \$1,000.00 toward Tina/Mary. Struggle with more than that. Q: How does board reject the bonus for employees? A: No. Go through audit, first. **MSP** Dan Harrison, Dave Blumberg. Motion for a \$1,000.00 bonus [total] for all hourly employees. No discussion. Passed
  - o \$1,500.00 bonus for Tina [hourly bookkeeper]? Based on performance perspective in relation to her work. MSP Dan Harrison, Dan Smoot. Motion for Tina to receive a \$1,500.00 bonus. No discussion. Passed
  - MSP Dan Harrison, Brad Strom. Motion for Mary to receive a \$2,000.00 bonus pending a successful completion audit of games by Russell and Associates. Discussion: No additional findings beyond [3] missing games. Then further discussion to follow. Passed

## Vice President: Justin Langbehn

- Jersey discussion: Have had 3 conversations with 3 different community service committees regarding the Park Indian logo being used. They are very upset. We need to figure out if this is something CGAA needs to take action. Court law said that the logo couldn't be used. Idea/motive behind usage: honor and respect the Indian. But in same respect, CGAA needs to prevent that logo from being used. Q: Hockey team? A: Yes. One team went out & paid for their own jerseys that have the Park HS Indianhead logo on it. W/in the hockey community, mixed emotions & questions: retro? If it is, then it is. But Divisions are responsible for what their teams wear. Q: did Hockey know about this? A: No. Hockey didn't sanction the usage of logo.
- Don't want the Main board to dictate what Divisions do, but everything needs to go through the respective board. Main should create directive regarding non-conformative uniform issue. Main Board agrees on matter regarding "special" uniforms w/in division, cannot deviate. Justin Langbehn will contact Charlie [Hockey President] regarding issue and communicate Main Board stand.
- Talked to rep at NGIN re: websites, CGAA would have to merge to one site to have comprehensive view of everything & membership. Options: 1) pull registration on website as a "mirror" [problem if rostering teams through NGIN, would lose that right, it would be on Main site, not Division site]; 2) data "dump" every year [problem, if every time done, would repeat data w/no filter]. 3) redesigning website. Most sites are becoming 'mobile ready'. CGAA website currently showing full-site vs. mobile ready which is easier to view. Cost would be minimal [\$1800/website] to refesh. Cost: \$235-40/month currently. Q: what would the cost be? A: \$6-7K. [Dan H] Want control of website to avoid future problems.
- O: [Tina] receiving check requests from members from Hockey A: trust but verity.
