I. Consent Agenda

- A. Approval of December 8, 2015 Monthly Meeting Minutes
 - **a.** Motion made by Hugh and seconded by Scott to approve. No further discussion, motion passed.
- B. Manager's Report Roger Ehrhorn
 - **a.** Ax Grinder year to date sales are \$1,974.
 - **b.** Discussion had on floor scrubber and the need for new batteries, discussed cost effective options for obtaining new batteries.
 - **c.** Discussion on need for new spreader towel for zamboni, \$100. Ordering one.
 - **d.** Discussion had on need for floor vacuums for lobby due to grit collecting in floor seams. Looking into options.
 - e. Discussion had on need to update rules sign in arena to better reflect current rules.
 - **f.** Discussion had on moving back mezzanine seats in heated area so not too close to glass to cut down on window cleaning. Reviewing site lines of seats to see if this is an option.
 - **g.** Discussion had on removing carpet from stairs due to cleaning difficulties. Looking into different flooring options.
 - h. Discussion had longer drying times for ice on East end of arena. Due to air intake vents being above that side of the rink so warmer air. Going to turn ice temp down to 14 degrees to see if that helps.
 - i. Need new replacement cover on exterior light pack.
 - **j.** Discussion had on replacing canned lights in the lobby with LED. LED would save on electricity cost as well. Checking into options.
 - **k.** Sound system has been fixed and is good as it can be.

a. Reviewed budget and financials.

- **a.** Same as last month. 3 spaces remaining including space above zamboni door.
- **b.** Discussion had on video for marketing appreciation for sponsors as well as being used for new sign marketing. Discussed possible options of who could do this type of work for no to low cost. Checking into options.
