In consideration for the acceptance by *TEAM Challenger FC - North ("TCFC North")* of the above-named player, and his/her parent's or guardian's request and/or application to participate in events, athletic or otherwise, and sponsored, sanctioned or unsanctioned, or participated in by Team Challenger FC - North ("TCFC North") and the provision of coaching of the Player by TCFC North, the player and his/her parent or guardian ("parent") undertake and agree as follows:

1. Player and Parent acknowledge that there are certain inherent dangers associated with participation in TCFC North Events, including without limitation, participation in indoor and outdoor soccer practices and competitions, sanctioned and unsanctioned practices and competitions, and travel to and from these events, and Player and Parents agree to exercise their discretion in driving to and from all such events.
2. Player and Parent acknowledge that TCFC North does not provide or maintain insurance of any kind whatsoever, including without limitation, insurance which would cover the cost of medical, dental, or therapy arising from participation in a TCFC North Event.
3. Player and Parent hereby assume any and all risks and hazard of injury to Player in the course of a TCFC North Event, including, but not limited to injury caused by physical contact with other participants, physical exertion, or playing conditions, including field conditions.
4. Parent and Player on behalf of themselves and their assignees release and hold harmless TCFC North from any and all liability and expense, including litigation costs and attorney fees arising out of any and all claims which Parent and/or Player may have, Parent and Player hereby waive all claims they may have against TCFC North, or any of its directors, officers, officials, employees, coaches, representatives, and agents, as a result of the Parent/Player participation in a TCFC North Event (including any transportation to and from the event) and including any facilities provided directly or indirectly by TCFC North. Parents and Players shall hold harmless and indemnify TCFC North and its affiliates from any and all claims, liabilities, and expenses arising out of claims brought by third-parties in connection with any acts or omissions of the Player and/or any parent, guardian, sibling or other relative of the Player who attends and participates in a TCFC North Event.
5. Parent and Player acknowledge that this document shall be operative as to any TCFC North Event scheduled as soccer now or in the future and for which Player is participating regardless of team, participants, facility or location.
6. Player and Parent hereby expressly grant unrestricted right and permission, free from approval, review, and cost, to photograph, record, video, or otherwise capture the player's image and/or likeness in all media, now or hereafter known, including without limitation, pictures and video, to copyright the same in its own name, and which may be included in any commercial or promotional use by TCFC North at its discretion on its website, social media sites, and any other website on which Player's image can be seen or heard. Player and Parent grant unrestricted right and permission to TCFC North to post and disseminate pictures, images, audio, and video of Player via the Internet, including via social media.
7. This Agreement shall be governed by the laws of the State of Ohio, and any claim arising out of this Agreement must be brought in Ohio.
8. Player and Parent acknowledge that they have the option of not applying for Player participation in TCFC North, and of Player not participating in TCFC North Events, if the terms of the foregoing are not acceptable.
9. Player and Parent acknowledge that there are no refunds issued by TCFC North and/or its affiliates, although in the event of cancelation of certain tournaments, then the tournament fees or pro-rated amount, may be credited to the Player's account.

Participation in such events or activities by my child and myself involves the possible exposure to and illness from infectious and/or communicable diseases including, but not limited to, COVID-19, MRSA, influenza, and other infectious or communicable diseases. While adherence to particular rules and requirements may reduce the risk of possible exposure, there is an inherent risk of exposure to COVID-19 exists in any public place where people are present and COVID-19 is an extremely contagious disease, so the risk of serious illness and death remains. By participating with TCFC North, you voluntarily assume all risks related to exposure to COVID-19; and,

If, however, I observe any violation of the rules, regulation or conditions established by Team Challenger FC - North, US Youth Soccer, Ohio North, or the State of Ohio during my presence or participation, I shall remove myself from participation and immediately bring such matter to the attention of Team Challenger FC - North; and,

TEAM CHALLENGER FC PARTICIPATION REQUIREMENTS

Participation in Team Challenger FC North

Any accepted players joining TCFC understand they are making a full year commitment to participate. This full year commitment includes fall, winter, and spring sessions; or in the case of players in high school this includes winter and spring sessions. Players may pay all annual fees in one lump sum at the commencement of their first session or players may choose to pay the annual fees by making payments. All payments are due upon receipt of registration link. Player and Parent acknowledge that there are no refunds issued by TCFC North and/or its affiliates. Players failing to make payments on time will incur late fees and will not be permitted to participate in training or game play until such time that full payment is made. Roster spots will be held for all players that make a full year commitment and pay all fees on time.

Registration into TCFC

All accepted players into TCFC are required to complete all registration steps prior to attending a training session or game. Registration steps include the following:

- Register in TCFC registration site and make full payment.
- Register in governing body registration as required for player carding; Upload birth certificate, upload player picture, and complete waiver registration.
- Full payment must be made prior to participation. There are no refunds, NO REFUNDS AT ANY TIME
- Order official TCFC game/training mandatory uniform kit to include all training gear and related mandatory player items.

Game and Practice Uniforms

All official TCFC uniforms are custom-manufactured and players should expect a six-eight week delivery. The club will attempt to keep inventory of replacement training jerseys and replacement socks for player purchase. However, it is strongly recommended that players purchase multiple sets as players will routinely train and participate in games.

All players are required to purchase the full TCFC uniform kit and the TCFC training kit and to wear only official TCFC game and training uniforms to all TCFC games and training sessions.

- Players are not permitted to modify their game uniform in any way.
- Players are not permitted to modify their training uniforms in any way.
- Players are not permitted to wear training uniforms displaying their name or player number.
- Players are not to make substitutes to the official game or official training uniform.
- TCFC must pre-approve all selected player numbers for game jerseys. Player numbers for teams/age groups must each be unique.

Club and Player Fundraisers

Throughout the year TCFC will offer a variety of fundraising opportunities. These fundraising opportunities are in place to benefit both TCFC and as an opportunity for players, to raise funds for the purpose of off-setting their registration fees. Players are required to participate accordingly.

Travel Policy for Tournaments, Showcases and League Games

- Players are expected to follow all TCFC club travel policies.
- Players are expected to stay in team assigned hotel.
- Players are required to attend all team meetings. Players should always anticipate that coaches will hold daily team meetings while traveling.
- Players are encouraged to attend all team meals. Any required attendance team meals will be communicated in advance.

Player code of conduct

- Players will at all times conduct themselves in accordance with TCFC player code of conduct policies.
- Disrespect to coaches, teammates, opponents or referees by players will not be tolerated, and might result in expulsion from the TCFC.
- Obtain plenty of rest and follow good nutritional practices in preparing for competition.
