Gambling Report Tracee deNeui - We had a good year, we did better than we thought. Provide

Tracee move to approval of the monthly report, expenses for July 2016, \$60250 and approval to make an ice time donation in the amount of \$25,000 to ACYHA for May 2016, seconded. Motion passed.

Banner update Jay Annis - The new banner project is underway and the first ones will start to go up this month. The champions' banner will go up starting from center ice. If you hear of someone who says, "Hey we won...." The response is great. We need some verification. Speak to Jay or Lisa for the formal process for that.

Board Transition Updates - Five minute overview on the positions

- Tournaments - next month
- Chair - Sign the monthly gambling report, meet with the Mayor and City Council members every two months, I support the HDC but do not say too much, help support the gambling program, fiduciary responsibility, Scholarship request and point person for the board and point person for the board for any outside entities
- D3 Representative - there are 10 teams in District Three; The D3 Representative is our board represents us at to the D3 organization. Attend the D3 monthly meeting and bring D3 info back to us. Works on getting district tournaments, making sure we are in compliance, helping D3 and MN Hockey keep the three organization in good communications. The D3 Executive Board is made up of people who run for those spots from any associations.
- Communications & Marketing Director - Recruitment is a big part of our role. We are marketing the association for the goal of recruitment and retention. We have been building the elementary school marketing and had good responses. Parades and elementary school open house. Work with Rachele on the Web site to ensure we use that as much as possible. Banner project around the arena to build the atmosphere and build the community with in the associations

- Ice Scheduler - Next month

Chairmen Report Buck Humphrey - The HDC is reworking the budget line items so that they better align with the contractors for the budget and invoicing. The categories were - Camps, Skill, and Dryland. Turn it over to Derrick Raymond to present. Full presentation attached, high level of the presentation is -- Danny Camps \$6,900, Sunday Skills \$24,500, Off-Ice Dryland and Open Gym \$24,480.00 (New Category), Sunday Skills Attitude Goaltending \$5,500 and \$1,650 for fall goalies camps, and In Seasons Goalie Training from Attitude goal tending \$9,500. The total for both vendors - Danny Charleston Hockey Training \$55,580 and Attitude Goaltending \$16,650. (Evaluations is not included in any of these numbers) Total for both vendors is \$72,230.00. For Danny and the dryland we will only get billed for what we use, we could end up using less.

This total of \$72,230, this is just over a \$7,000 increase to the budget that was approved for the annual budget.

If the facility for dryland is not getting used we have the flexibility to scale back the open hours and we agree that we need to push the opportunity out to our coaches and players. We need to have a schedule out there that people can access.

Buck made a motion to approve the proposed budget in detail (see attached), second. Motion rescinded. New Motion offered.

Motion to approve the proposed HDC budget revisions in detail (see attached) and that the Chair will select and appoint a person to manage the Off-Ice Program for the seasons by July, seconded. Motion Passed.

Treasurer Eric Jeffreys-Berns - Monthly report went out, attached.

District Three Report Jim Tuchtenhagen (Full report sent to board in advance - attached)
We present to host the D3 District AA PeeWee tournament; we did not win the vote. District Three Executive Board, Tom Elmer is the new District Direct, Ron Walsh is the new President. There is a Treasurer position open and a Metro League Rep position open. Fall Level 4 clinic in Bloomington, share with coaches. One week prior to the scheduling meeting is the dead line to confirm our teams.

The super mites are ending up playing more games than a squirt in a season. The district is looking to put some rules in place so that they can police, the district level for to look at full and half ice.

Mite Director Brian Thul - We presented to the Golden Valley Open Spaces and Rec Committee to thank them for letting us use their outdoor rinks. They would love to see us use them more, maybe a Saturday drop in hockey type of event. We have a good relationship with them, and they welcome any used sticks.

Try Hockey for Free Dates - see attached for complete list of who will coach and additional elements that are going on at that event. Dates are - Sept 17, Sept 24, Oct 1, Oct 8, Nov 12, Nov 13, Family Pond Hockey, Feb 25.

Dates for Learn to skate clinic are Oct 15, Oct 22, Oct 29, Nov 5 for a 30 minutes session. We will charge \$50 for the session and if you register your \$50 fee gets applied to your new registration. The fee transfer for registration is a new member offer only. This would also allow us to shorten the mini mite program which is currently too long. This will better get them ready.

So the cycle is try hockey for free 8 times, then four chances to for the Clinics then going into the Mini Mite program. We will have to push the Mini Mite photos back a bit, note to Julie Ann.

Volunteer Hours and the Elite Tournament - Tawnia & Stephanie - The two of the AAA tournaments were cancelled, that we have had the past 5 years. The impact is that we lose \$5,000 -\$10,000 in concessions revenue, we have to pass that loss on by increase fees, we also cannot pay the June and July rent until August. The city has been informed.

Hours were also impacted affecting 20 families. Of the 20 families, five said cash my check, ten no response and five would like to finish. The five that said to cash the check is done. The ten that did not respond we will cash their check. The five that want to finish are all close to being done. Suggest that we allow them to work the summer August hours but they need to get done by August 31st. Stephanie will work with the five families.

The Elite Tournaments in August, September and October is a point for discussion. We are contractually obligated to run concessions, but we also do volunteer hours for other elements to run the tournament. We do not make any money other than concessions. The City owns the contract with Elite. There has been talk of wanting to no longer support the two tournaments beyond the concessions that we have to fill due to our city contract. This is a big picture issue. Jenn/Susie, Buck, Carla and the Elite contact will take this off line.

Registrar Crissy Ginther - (See attached) We need people to sign up in a more timely manner so that we can plan. I worked with Jerry to brainstorm and some good ideas. Proposed pricing does not change but we added a payment so that you make a smaller first payment and then four more payments. The hope is that those that register later to hold on to their money will have an easier time registering early, because they are not paying all the money so early.

In addition we would really like to incent our members to register earlier so that we can properly plan.

Regarding Junior gold, proposed raising the registration from \$800 registration fee, and \$300 volunteer deposit/10 hours of tournament hours only to just the registration of \$1,050 and no volunteer hours. We are significantly below other clubs in our registration fee. There was a calculation at one time the cost is about \$1,000 per player but this is a very fluid thing and it is really hard to calculate until we really know what we have for skaters. The competitive numbers to other clubs numbers are, Wayzata is \$1500-2000, SLP is \$1040, Mpls is \$1200.

Discussion on fees and hours, numerous options reviewed. Much discussion was had.

Motion to open Travel Hockey registration on July 15th, travel hockey rates will stay the same and we have a new payment structure so that we have a smaller first payment of \$100 is due at registration, And move the travel hockey late registration penalty to August 5th. And for Junior Gold the registration (date to be determined later) is \$900 registration fee, by Crissy, seconded. Motion passed.

New Mite registration structure (see attached new structure)(pervious structure is on the full registration fees attachment) - The goal is that the middle players mite 1 and 2 have the same rate and in the house fee category. It allows the Mite Director to move kids around a bit more at the middle level without the cost being an impact in the decision. This is being done to make the program management make more sense and fit the new philosophy, not to raise money. We will not lose money in the new structure. Reminder that the \$50 at the new learn to skate camp will be applied to new registration

Motion to make mite program registration fees as follows, the mini mites \$50, Mite 1 & Mite 2 at the house fee \$250 and Mite 3 at the travel fee \$450, seconded. Motion passed.

Buck appointed these 5 Level Coordinators, no board vote.

Dave proposed that that all level coordinators receive full hours for their position, second. Motion passed.

ACE Assistant Matt Cook - - Working on securing coaches and marketing coach opportunities. Buck share that HDC is going to use needs to be the determining factor for if we have paid coaches vs not. Dave share that we have a lot of emphasis on non-parent coach regardless of qualification. How you get around the coaching your own player

and placing teams. The process would be rank all the coaches and they are assigned to teams by rank and they can coach down to coach their own kids. This is just the discussion going on at HDC, nothing is being planned. The conversations are still on going.

Girls Travel Director Jerry Mlekoday -10,000 Shot Challenge, tabled to next month.
