

GBAYHA SCRIP PROGRAM POLICY

Green Bay Area Youth Hockey Association (GBAYHA) (referred to herein as “we”, “us”, and “our”) sponsors a SCRIP program which allows families of current GBAYHA skaters to purchase SCRIP gift cards. The SCRIP gift cards purchased through our program generate rebates from the participating retailers chosen by GBAYHA and the Great Lakes SCRIP company.

The program is administered as follows:

- A.) For administering the SCRIP program, GBAYHA will retain 10% of the rebates received from SCRIP purchases as an administration fee and association-wide fund raiser.
- B.) The remaining 90% of the earned rebate amounts per skater (aka Family’s Portion of Earned Rebate) can be used as:
 - 1.) A credit to the skater’s registration fee at the start of each GBAYHA hockey season. Excess funds above the registration fee will be paid to the skater’s family as a check.
 - 2.) A 1-time cash-out after the skater’s last hockey season with GBAYHA. A check for the family’s portion of the earned rebate will be written to each family after July 1st following the last season for the skater. Only balances greater than or equal to \$5.00 will be paid out. Balances less than \$5.00 will be considered donations to GBAYHA.
 - 3.) A gift to GBAYHA if so designated by the family.
- C.) All SCRIP gift card orders will be placed on the Great Lakes SCRIP website (<http://www.shopwithscrip.com>) and all payments will be made with *PrestoPay*, a service provided by Great Lakes SCRIP for Electronic Fund Transfers (EFT) directly from a linked banking account. Great Lakes SCRIP charges \$0.15 per transaction. (*PrestoPay* registration can be found on the bottom of your Dashboard page)
- D.) July 1st will mark the start of each SCRIP season so that rebates earned prior to July 1st can be used for the upcoming GBAYHA hockey season. July 1st will also be the cutoff for skaters that are no longer registering with GBAYHA for the upcoming season. The 1-time cash-out option will be available for the family’s portion of the rebate earned during the season prior to July 1st. The date range for reporting rebates is July 1 to June 30.
- E.) Contact information (phone number, etc.) and the designated skater’s name must be specified on your Great Lakes SCRIP website account profile. The skater’s name may be changed at any time to apply to a different current skater of GBAYHA.
- F.) By participating, you agree to indemnify GBAYHA against any loss incurred in connection with insufficient funds in your account to cover the *PrestoPay* EFT transfers you issue to pay for your SCRIP gift cards. You will reimburse GBAYHA for fees incurred due to insufficient funds.
- G.) GBAYHA makes no representations or warranties of any kind with respect to the SCRIP gift cards or the businesses represented by them.
- H.) This policy can be amended at any time by the GBAYHA Board of Directors.
