

“From Rockland to the Rockies” Contest
OFFICIAL RULES

No Purchase Necessary. Purchase Does Not Increase Odds of Winning

- 1. ELIGIBILITY.** Contest is offered only in the United States and Canada to legal residents of those countries. If you are under 18 years old, consent of your parent or guardian is necessary for you to enter. All required information relating to such parent or guardian consent must be completed in full for your entry to be eligible (along with any other requirements noted in these Official Rules). Employees, directors, officers, agents and affiliates of Bottom 9 Baseball, LLC and Palisades Credit Union (“Sponsor”), participating media organizations, and all of their respective parents, affiliated and subsidiary companies and the immediate family (spouse, mother, father, sister, brother, daughter or son, regardless of where they live) or members of their same households (whether related or not) of such employees, officers, agents, affiliates and directors are not eligible.

Where indicated, provide your name, zip code, date of birth, e-mail address, phone number and any other required fields. (2) Visit the Rockland Boulders sales table located behind section 107 anytime during the Promotional Period when the Boulders are playing a home game at Palisades Credit Union Park and fill out an official entry form. (3) Send a 3 x 5 card with your name, zip code, date of birth and e-mail address and phone number to: Rockland Boulders Baseball “From Rockland to the Rockies,” c/o Palisades Credit Union Park 1 Provident Bank Park Drive Pomona, NY 10970. If you are under 18 years old, please have a parent or guardian sign the card indicating that you have permission to enter. All entries must be received by the Contest deadline, as noted in section 3 of these Official Rules.

Entries received after such dates will not be eligible. For all means of entry, all requested information must be provided in its entirety in order for your entry to be eligible. Sponsor shall not be responsible for lost, late, incomplete, stolen, misdirected, illegible entries; or for any computer, telephone, cable, network, satellite, electronic or Internet hardware or software malfunctions, failures, connections, availability or garbled or jumbled transmissions, or service provider/Internet/web site/use net accessibility or availability, traffic congestion, or unauthorized human intervention, or the incorrect or inaccurate capture of entry or other information, or the failure to capture any such information.

9. **ARBITRATION; CHOICE OF LAW.** Except where prohibited, entrants agree that: (a) any and all disputes, claims, and causes of action arising out of or connected with this contest shall be resolved individually, without resort to any form of class action, and exclusively by arbitration pursuant to the Rules of the America Arbitration Association; (b) any and all claims, judgments and awards shall be limited to actual out-of-pocket costs incurred, including costs associated with entering this contest but in no event attorney's fees; and (c) under no circumstances will entrant be permitted to obtain awards for and entrant hereby waives all rights to claim punitive, incidental and consequential damages and any other damages, other than for actual out-of-pocket expenses, and any and all rights to have damages multiplied or otherwise increased. Moreover, all issues and questions concerning the construction, validity, interpretation and enforceability of these Official Rules, or the rights and obligations of entrant and Sponsor in connection with the contest, shall be governed by, and construed in accordance with, the laws of the State of New York, without regard for conflicts of law principles, and all proceedings shall take place in that State.
10. **GENERAL CONDITIONS.** Sponsor reserves the right to cancel, suspend and/or modify any part of the contest if any fraud, virus or other technical problem corrupts the administration, security, or proper execution of the contest, as determined by Sponsor in its sole discretion. In such event, Sponsor reserves the right to award the prizes in accordance with the selection processes described above. Sponsor reserves the right in its sole discretion to disqualify any individual it finds to be tampering with the entry process or the operation of the contest or to be acting in violation of these Official Rules or in an unsportsmanlike or disruptive manner. Any attempt by any person to deliberately undermine the legitimate operation of the contest may be a violation of criminal and civil law, and, should such an attempt be made, Sponsor reserves the right to seek damages from any such person to the fullest extent permitted by law. Sponsor's failure to enforce any term of these Official Rules shall not constitute a waiver of that provision. In the event of a dispute as to any online entry, the authorized account holder of the e-mail address used to enter will be deemed to be the entrant. The "authorized account holder" is the natural person assigned an email address by an Internet access provider, online service provider or other organization responsible for assigning email addresses for the domain associated with the submitted

address.
