Due to the delay in receiving the results of these CRC's, TPMHA is considering holding a special Fall AGM to work out some details in regards to this delay. Dave will obtain some information to distribute to the executive to determine if or how we will proceed with a Fall AGM.

7. New Business

- a. A request has been made by a parent of an Atom age player to have their child attend Peewee tryouts. The parent has not applied to have their child play up in Peewee. It is the recommendation of the committee that players should really be playing in their own prospective age level. The parents though, should they so desire, are eligible to follow the necessary steps to apply to have their child play at the Peewee level. Player advocate to handle response.

Communities can apply to host this event, which consists of ice practice, parent presentations, coach mentorship, clinics tailored to IP/Novice, etc. Wes and Jerome will sit in on a conference call to learn more about this type of event and what is required should we decide to apply to host.

- c. A Peewee age child, playing hockey for the first time ever, will be going on the ice with the Atom group this weekend as a trial. The parents feel the child may not be capable of playing at the Peewee level.
