- 1) Treasurer's Report. Motioned and approved.
- 2) Review August Meeting Minutes. Motioned and approved.
- 3) Update to DCYH bylaws
 - a. Request from a past-past president to be included on all board emails. Motion made to amend the DCYH bylaws under the section Officers/President Responsibilities/Section "d" to say:

"He/she shall have such other duties as may, from time to time, be assigned to him/her by the board of directors. The president shall also serve on the board as an honorary, non-voting member, after his/her term has expired in an advisory position *limited to the next president's term*."
