Our All Star Team will be going on a training camp to Holland and will attend the World Championship Meet.

Discussion followed regarding organization and growth of future Region 7 camps.

The summer training camp will go out to Region 7 clubs bid, with the host club taking over financial management. This will include retaining net profits from proceeds. The RJOCC will create a manual for host clubs to follow, and will continue overseeing all operations and implementation to maintain Regional camp philosophy and mission. We will be looking for bids this year for the summer 2011 camp.
