





Six Elected to Softball Hall of Fame

Veterans selected from slow pitch, fast pitch, umpires, sponsors and administrator ranks

Six veteran softball enthusiasts were elected as the latest to be added to the North Dakota Amateur Softball Hall of Fame. The inductees will be honored at a formal induction ceremony and banquet held in conjunction with the annual Spring meeting of the NDASA on Saturday, April 16, 2011.

This year's inductees cover the entire range of participation in amateur softball with the selection of slow pitch players, an outstanding fast pitch player, an umpire, a sponsor and an administrator who also played for many years

Selected were Randy Anderson of Turtle Lake, Ray Brew of Dickinson, Paul "Otto" Ferrie of Fargo, Gail Ingwalson of Grand Forks, Rick Fryhling of Fargo and Harold Wilkens of Center.

Randy Anderson

A resident of Turtle Lake, Anderson has played in that city since he began his playing career at age 14. His career, mainly at shortstop has continued for 36 years. He has always been an outstanding hitter and defensive player. He has played for three sponsors in his home town including Marv's Bar

which he has managed for the past 22 years. His teams have won three state tournaments and played in one national. In addition to his years as a player, Randy began umpiring in 1976 and has been a registered ASA umpire for over 30 years with most of his umpiring done in his local area. He is credited with keeping softball alive and flourishing in the Turtle Lake community and area.

He was instrumental in developing the four diamond complex in his home town which is heavily used during the season. Randy spends many hours performing maintenance and upkeep of this facility and has also acted as Tournament Manager for many invitational tournaments held in the area. He also started a program for young girls softball in his home town.

Ray Brew

Ray Brew of Dickinson began his long career in 1972 playing for several different sponsors over a 38 year career. Playing in the outfield and as a catcher he has played in 40 state tournaments and two regionals.

Three state titles for teams on which he starred are the Class AA in 1978 with Liberty

National Bank; Class D in 2004 with Logo Magic and in Rec II in 2008 with Simonson's. He was selected as an all tournament player is several of these tournaments, MVP in others and as a Homerun Derby Champ.

Early in his softball career, Brew was noted as a feared power hitter who could also hit for average and as a good defensive outfielder with some of the best teams in the state. Later he transformed himself into an excellent base hitter who could hit the ball to all fields.

Known for his passion for the game, Brew would never let his teammates down no matter what the score. He was a fierce competitor while at the same time he remained a gentleman on and off the field. His lifetime batting average is estimated conservatively at .575 and he estimates that he has hit over 800 homeruns in his long career.

Paul "Otto" Ferrie

Ferrie came from a family of softball pitchers. Both his father Paul and his uncle Roger are in the South Dakota Softball Hall of Fame. He started pitching fast pitch softball when he was eleven years old in Sioux Falls, South Dakota. His teams were

highly successful at the junior level. In 1962 he played in both the Youth League and the Men's City league. Before the season ended, his family moved to Wahpeton, North Dakota where his dad organized a team so he had the opportunity to play with his dad. In 1965 and 1967 he pitched his team to the state title in Class B fast pitch softball.

His longest service as a pitcher and his best years were in the Twin City League in Fargo where he starred as a pitcher and played first base when not on the mound. He was an outstanding left handed pitcher for Josefs of Fargo winning their first state tournament in 1977 and again in 1978. It was the first time in 25 years that a team had managed to win back to back state titles in the very competitive fast pitch which was played in North Dakota softball at that time.

Ferrie had 25 no hit ball games in his 29 year career along with 40 one hit games and a career total of 650 wins against 190 losses. He was also a dangerous power hitter with an average of approximately. 275.

President's Report

Welcome again to another softball season in North Dakota. Rules clinics will be held throughout the State in April and the season will begin shortly thereafter.

I attended the ASA National Council meeting this past November with Commissioner Hanley, Mike Wolf, Walt Stack, and Bill Butterfield. The Council meeting was very productive and informative. A

SA Rule and Code changes are printed in this newspaper as well as the NDASA Web site. Just a few highlights of the rule changes are 1) 70' Bases Men's A & B Slow Pitch; 2) Approved bats shall be considered altered if they are rolled, shaved, repainted, weighted or modified to change their characteristics from that produced by the manufacturer; 3) E/Rec uniform requirement will be matching shirts with numbers; 4) One and One count will now be used in Masters Slow Pitch Classification; 5) Approval of an additional 12" softball for Slow Pitch Classification of play. The new additional ball certification is a 52/300 which is less temperature sensitive, reduces batted ball speed, and increases player reaction time.

The ASA Equipment Testing and Certification Committee has done extensive lab and field testing on the 52/300 and are encouraged by the results. I would encourage leagues and tournaments to give this ball a try. The ball should be

available by all ball manufacturers by June or July of this year.

Other good news from the ASA Council meeting is that Bismarck and Minot received the James Ferrell award of Excellence for holding two of the highest rated National Tournaments in the country. Bismarck held the Men's E/ Rec and Minot the Women's C&D. Congrats to both cities and their tremendous volunteer base. The city of Mandan was also successful at the council meeting in Shreveport securing the bid to hold the ASA Men's Master's 35 Slow Pitch National Championship in 2012. North Dakota has held this Championship in the past with much success.

ASA National Tournaments in our region during the 2011 season are: MSP C Slow Pitch in Bismarck/Labor Day weekend, WSP C&D in Bloomington, Mn./Labor Day weekend, Coed Open, C & D in Bloomington/ 8/25-28, JO Slow Pitch 10U-18U in Watertown, SD/7/28-31, JO 10U A/B, and 18B in Rochester, Mn. 8/4-7. These ASA National Tournaments provide tremendous opportunity for youth and adult in our program, please take advantage. Every city listed has experience running national tournaments and will provide players and fans with unforgettable moments.

The NDASA Executive Board made several appointments at the mid-winter meeting that will enhance the day to day operation of our program in North Dakota.

Mary Hager of Harvey and Sue Lachenmier of Bismarck were appointed to the NDASA Executive Board. Roger Weigel of Bismarck was appointed NDASA Tournament Coordinator replacing long time NDASA volunteer Kathy Stefonek.

Mike Peterson of Fargo was appointed Asst. Tournament Coordinator and will chair the new Player Classification committee which includes Roger Weigel of Bismarck, and Scott Brahos of Mandan. Scott Schafer of Jamestown was also appointed JO Slow Pitch Commissioner. Each of these appointments are important to the NDASA program and I thank each of you for stepping forward.

In the last two years, ASA has established a National Player Classification Data Base Slow Pitch. Previously all players who have participated in National Play the last few years have been placed in the data base of the class they participated in. This data base is an attempt by ASA to provide more uniformity in the classification system, by classifying players who make up ASA teams.

This past winter, Jack Jones of Mandan was so kind as to input all players from B through Rec II in North Dakota into the national data base. Rec I & II players were placed in the E/Rec division. A player may appeal his classification by going to the ASA web site. The new Player Classification Com-

mittee Chaired by Mike Peterson of Fargo will assist Commissioner Hanley in this process. The Player Classification process was changed slightly at the Council meeting whereby a player can hold a + to his or her player classification. For instance, if a player was reclassified from C to D+, that player could not play in the E/Rec classification in Championship play. Normally, an E/Rec team could have three (3) D players. So, the new rule allows the C player to go to D+ and play D, but not slide to E/Rec as one of the allowable three D's.

I think we are all learning along the way and the system will continue to be tweaked and improved.

I would like to thank Gary and Connie Tharaldson and Tharaldson Enterprises for again sponsoring the trophies and banners for all State & National Tournaments in North Dakota in 2011. This is a significant donation to our program and helps keep the entry fees at an affordable level for our teams. Be sure to thank Gary and Connie when you see them.

See changes in this newspaper to allow later roster dates and roster change dates for NDASA play this year. Also for the first time we are allowing two (2) pick up players for State Tournaments. Both of these changes approved by the Executive Board with input from the Women's and Men's program will assist teams and opportunity for participation in the NDASA

Congratulations to the NDASA Hall of Fame Class of 2011. Randal Anderson of Turtle Lake, Ray Brew of Dickinson, Paul (Otto) Ferrie of Moorhead, Gail Ingwalson of Grand Forks, Harold Wilkens of Center, and a long time friend of NDASA Softball, awarded posthumously, Rick Fryling.

A special thanks to the Commissioner Hanley, the NDASA Executive Board, NDASA Advisory Board, League Reps, Umpires, Tournament Directors, and the hundreds of volunteers who make it possible to run our program in North Dakota. We couldn't do it without you. Keep up the good work and have a great softball season in 2011.

From Behind the Catcher

Just the middle of February as I write this but I'm thinking of Spring and softball already. We have had a brutal winter and we still have several weeks to put up with it, not to mention the probability of Spring flooding in many areas of the state.

Despite that I am working on this issue of the Softball News and I feel much better about the weather. I also went to Oklahoma City the first weekend in February for the biannual UIC Workshop and clinic. I was hoping that Oklahoma would greet us with some decent weather but they had a gigantic snow storm the day before I flew in with 12 inches of snow. It was pretty obvious that they don't know how to handle that amount of snow and my guess is that the city only has one snow plow.

The streets were snow packed and some of the entrances to the motel were blocked with snow. Our motel had some problems with water pipes and there was no hot water in my room the first day. The featured speaker was snowbound in Dallas and didn't get to the meeting at all

Despite all those problems, over 400 ASA umpires were there for the workshops and presentations by members of the National Staff. It was great to talk about softball again and think about the upcom-

ing season.

One of the exciting aspects of the workshop was the introduction of the new instructional DVD's developed by the National Staff. These include umpire mechanics featuring base umpire mechanics for fast pitch within the two umpire system and base mechanics for slow pitch within the one umpire system and the two umpire system. A third DVD was not available due to shipping difficulties caused by the weather. That one will feature the three umpire system in both fast pitch and slow pitch.

I hope that each of you has had a chance to view the first umpire DVD which was released two years ago and that you will also get to a clinic where the new ones will be available. Each of us who attended the Oklahoma workshop got a copy of each and Mike Wolf, state UIC, has ordered copies for each of his deputies so they will be available at local clinics held around the state. ASA has produced a quality teaching product and it will be a benefit to every umpire who watches it.

I also got my 2011 ASA rule book, umpire edition and while paging through it I found a very useful tool on pages 109 and 110. It is called "The Penalty Page" and it lists the various penalties for most of the common problems an umpire

will encounter and must be able to apply the correct penalty. Instead of having to page through the book to find the right rule and section number which sets out the penalties, they are listed for us. Great tool and one that will help all of us.

Another new development which was discussed at the workshop was the new softball which has been approved for use in all ASA ball for this season. It has characteristics which slow down the batted ball speed, which make the ball less harmful if it does hit a defensive player and is not as sensitive to hot and cold weather. It is described in Rule 3, Section 3. Dick Gulmon, NDASA President and Chairman of the national Equipment Rules Committee has an article in this issue better describing the ball.

In my opinion, this ball MAY be the solution to our problems and may reduce or eliminate the list of Non-Approved bats.

The ball is available for this season but not required until the 2012 season.

There have been some changes to the Executive Committee of NDASA and there are a couple of new people in positions long held by others but the profiles on these people will be detailed in the Summer issue of this newspaper due to space requirements.

My congratulations to the six new members of the NDASA Hall of Fame. They are Randy Anderson of Turtle Lake, Ray Brew of Dickinson, Rick Fryhling of Fargo, Paul "Otto" Ferrie, Jr. of Fargo, Gail Ingwalson of Grand Forks and Harold Wilkens of Center.

They will be inducted at a banquet and induction ceremony on Saturday evening, April 16. The ceremony is held in conjunction with the annual Spring meeting of NDASA to enable those people involved in NDASA to stay for the evening. All are invited to help honor these softball veterans.

Last, but certainly not least, I want to congratulate Mike Wolf

of Bismarck who is the NDASA umpire in chief. Mike received the Regional Umpire Award of Excellence for the Northern Region at the UIC Workshop and Clinic in Oklahoma City.

Unfortunately, due to work considerations, Mike was unable to attend this event but was recognized by his peers as the Outstanding Umpire in the Region. This award is made by the Regional Umpire in Chief every two years. There is a separate story and photo of Mike elsewhere in this issue but I want to express my admiration for Mike and all that he accomplishes as state UIC as well as his other activities including recruiting and scheduling all the umpires for the massive McQuade Tournament and his involvement in church and school activities. Commissioner's Column

With the advent of spring training it means many are thinking of outdoor activities in North Dakota. If you plan on playing softball in 2011, it would now be a good time to have your team and league organization meeting.

NDASA softball has made some changes, those following ASA and some to make softball better in North Dakota. Changes have been made to our executive board. Long time members, Kathy Stefonek and Kathy Corbett and have resigned and been replaced by Women's Commissioner, Mary Hager, and Women's State President, Sue Lachenmeier.

Wayne Beyer has filled the vacant position. Scott Schafer has been named GSP Commissioner and Roster coordinator for all adult and GSP. Roger Weigel has assumed a new position, Adult Tournament Coordinator, working in conjunction with Mike Peterson as Assistant Tournament Coordinator. Mike will be in charge of all MSP classification change requests. He will be assisted by Scott Brahos and Roger Weigle.

He will also work with marketing and research activities for tournament and game management possibilities. These appointments are welcomed and will make NDASA more transparent. Hopefully your inquiries and information requests can be handled to satisfaction and in a very short time.

The Northern Region of ASA, consisting of Minneapolis, Minnesota, South Dakota and North Dakota, will host five national tournaments in 2011. JO GSP (10U—18U) 7/28-31 in Watertown, JO GFP (10U-18U) 8/4-7 in Rochester, Coed Open, C & D 8/25-28 in Bloomington, WSP C & D (Labor Day weekend) in Bloomington and MSP C Northern (Labor Day Weekend) in Bismarck.

To participate in the adult tournaments teams must play in their NDASA state tournament and be registered with North Dakota ASA. Coed teams can be made up due to their state tournament falling in September. For JO participation the requirements are the same as adults plus GFP must be individually registered (contact Bill Butterfield) and for GSP teams must be individually registered after their state tournament (contact Scott Schafer). Individual registration fee remains the same as last year (\$8.00/player) NDASA will pay the national entry

fee to the state champion in all divisions of play or the next highest finisher.

A major change involves pickup players for state tournaments. In the past there was no pick up players allowed for state tournaments. This has been changed: "Teams entering state tournaments for all men's and women's division of play can pick-up a maximum of two players. Maximum number of players including pick-up players is 12. Pick-up players must come from your team classification or lower, and from teams not drawn into the state tournament brackets.

The pick-up player classification is from their highest team classification or player data base, whichever classification is greater. Pick-up player form must be signed by league rep and submitted to tournament director prior to first game. If form is not signed by league rep, form is not valid. Pick-up players must wear their own team uniform. This form will be available from your league rep or the state office.

Other changes include:

Umpire fees for adult and GSP state tournaments increased to \$20.00/game while GFP increased to \$30.00/game.

Every umpire must have a background check (every year) and must be conducted through ASA only.

Background checks in GSP and GFP must be conducted for everyone who is on the field of play.

Team registration deadline is 6/1/11. Late registration will have an assessment fee of \$10.00.

Rosters must be due in the NDA-SA state office by 6/17/11—after 6/17/11 a late fee of \$25.00 will be added.

Roster change date deadline is now 7/1/11. Mail changes to Scott Schafer until 6/25/11. After that date fax or e-mail to Scott.

Roster changes after the July 1st date must come to the MSP or WSP Commissioners. Final approval must be accepted by the state commissioner, state president and state tournament coordinator.

A very special congratulations to Mr. Gary Tharaldson who was elected to the National ASA Hall of Fame in the sponsor category. Gary will be inducted at the national meeting in Myrtle Beach, SC in November 2011.

I would also like to congratulate the new inductees into the NDASA Hall of Fame. They are: Randy A Anderson, Ray Brew, Paul (Otto)

Jim Hanley

Ferrie, Rick Fryhling, Gail Ingwalson and Harold Wilkens. Induction ceremonies will take place in Jamestown during the evening of April 16, 2011. Plan to attend and support our new inductees.

Ump Chat

Hello softball fans—the time is near. Let's keep our fingers crossed that flooding doesn't affect our plans to get softball going on schedule this spring! The upcoming season comes with minimal new rule changes. I am sure Dick Gulmon will talk about the upcoming changes with the softball, so I will leave that up to him to cover in his article.

The base distance for all levels to move to 70 feet was narrowly defeated. Parks and Rec districts and softball leagues throughout North Dakota should be preparing themselves for this change because it is only a matter of time before this rule change passes. The 70 foot base distance did pass for Men's Class A & B, and I am currently working with Bismarck Parks and Rec to get this change implemented in time for the McQuade Tourna-

A great rule change which I was an advocate from the start came in the form of allowing teams that play in the Men's E/Rec Nationals will now only have to have jerseys that match instead of having full uniforms. Also, umpires, gray ball bags with ASA lettering may now be worn with gray pants. Another good rule change was that in the Master's Divisions, the one and one count will now be used in state and national tournaments.

Even though we don't all like it—including me, the ten foot arc will remain in effect for 2011. Overall, I think umpires and players adapted fairly well to the ten foot arc rule. However, I witnessed a lot of inconsistencies in calling the ten foot arc from umpire to umpire and that is the biggest issue with players -especially pitchers that had to continually adjust to it. I have visited with hundreds of players on this issue we will continue to work with umpires to be consistent in calling illegal pitches that exceed ten feet. A rule change to put the arc back at twelve feet was proposed at the national meeting which I voted for, but unfortunately it was defeated.

We will be holding several field clinics for umpires throughout the state that everyone is invited to attend. At past field clinics we have stretched a string ten feet high and another string six feet high between the pitchers mound and home plate to use as a training tool for umpires to see where the ten foot limit is and where the six foot minimum is.

I highly recommend that pitchers, players, and managers take the time to attend the portion of the field clinic at the beginning where we cover the pitching height to get a true feel of where the ten foot arc limit really is. Last year we had a lot of players attend our field clinics and a lot of eyes were opened at our field clinics by players and umpires alike when we stretch the string and start throwing pitches. So, please consider attending a field clinic and take a look at the pitching arc. There is a complete listing of field clinics listed elsewhere in this issue.

I was fortunate enough to attend the ASA National Conference in Shreveport, LA in November, It was great to see some old friends and also meet some new people. Besides making playing rule changes and code changes, cities from across the country come to bid on hosting national tournaments. We were able to secure the Men's 35 & Over National Tournament for Mandan in 2012. I was fortunate enough to be able to be a voting delegate at the national conference and it was a great experience.

We will have a lot of opportunities for umpires from ND to work national tournaments this summer. Bismarck will be hosting the Men's C National Tournament over Labor Day Weekend. Other opportunities for our umpires and teams within our region include the Girl's 16U National in Rochester, MN and the Girls 16U Slowpitch in Watertown, SD. I am also working on some umpire exchanges for national tournaments outside our region.

It is also time for my annual plea to recruit more umpires. Leagues around the state are growing, and some umpires retire, and some just don't come back, so we are always in need of new umpires. Every city in North Dakota will need more umpires. Players can make good umpires because they have a keen knowledge of the rules and a feel for the game. Plus, where else can you find a part-time job—outdoors, where you can make around twenty dollars and hour?

If you have any interest at all to umpire, please contact me and I can put you in touch with someone from your area of the state. Or, check out the listing of the field and classroom clinics in this issue and you can show up and register. If you have any questions or concerns about umpiring, please contact me and I'd be happy to visit with you. Umpiring only one night a week can make a huge difference in helping out your local league.

I would like to let you know who our Deputy UIC's are throughout the state and I would also like thank all of my Deputy UIC's throughout the state for the great job they do for NDASA. They all bring a vast amount of knowledge and experience and are a valuable asset to NDASA. Our DUIC's are: Lyle Rader—Wahpeton, Naomi Erdahl—Bismarck, Don Daniel— Williston, Tom Harty—Jamestown, Elliott Gerhardt—Bismarck, Rom Smith-Minot, Pat "Rock" Healey-Grand Forks, Mike Lien-Fargo, Mike Nider—Bismarck, Randy Olson-West Fargo, and Al Ziemann—Bismarck. I have

also added a new DUIC in the Bismarck region and that is Terry O'Clair. Terry is a veteran umpire with several years of experience and several national tournaments under his belt. He will be a great addition to our current DUIC staff! Welcome aboard Terry!!! I have been informed that Gerald "Shorty" Payne has been appointed as the UIC for the Grand Forks men's and women's leagues. Shorty is also a veteran umpire and will do a great job for the Grand Forks leagues!

Bismarck/Mandan gearing up for McQuade Tournament

The 36th annual Sam McQuade Sr. Budweiser Charity Softball Tournament is rapidly approaching and will be held June 24, 25, and 26. As of March 1st, we already have over 180 teams registered compared to 125 teams at the same time last year. To celebrate our 36th anniversary, we are in the process of making arrangements to bring in the Men's Team USA to play two exhibition games on Friday night.

This is a very expensive venture and we are in the process of trying to raise \$15,000 to bring in Team USA. We WILL NOT be using any of the monies we raise to give to our charities, so we need to raise these funds outside the normal scope of our tournament. If you would or someone you know would like to donate to this worthy cause, please contact me or send your donation to the McQuade Tournament, Team USA Sponsorship, P.O. Box 1196, Bismarck, ND, 58502. We will have some additional softball vendors at the tournament this year and one of those vendors is planning to bring in a former major league baseball player who is a spokesperson for their company.

Team USA will be playing two exhibition games on Friday night and we will be assembling two teams to compete against Team USA. One team will be made up of players exclusively from North Dakota and one team will be made up of players who are playing in the McQuade Men's A/B division. A committee will be set up to determine which players will be selected to participate against Team USA.

This year we are losing a few

diamonds in Mandan that are being converted into baseball diamonds and last year we lost a couple diamonds in Bismarck for the same reasons and therefore, we need to be creative in finding a way to allow as many teams as possible to compete in the McQuade tournament.

As a result, for the time being, we will continue to keep the men's D as a two game guarantee division. We are also scaling back the women's D division from a double elimination tournament to a two game guarantee division. The teams in these divisions should be aware that with only 24 teams, these divisions fill VERY fast so please do not hesitate to get your tournament entry in ASAP!

Last year, we combined the men's Rec 3 and Rec 4 divisions. That decision worked out very well, so this year, we will continue to have a separate forty-eight team Rec 4 division and two sixty-four team Rec 3 divisions. This is a great opportunity for Rec 4 teams to compete for a trophy against teams of their own caliber. Once the Rec 4 division is filled, overflow teams will be placed into one of the Rec 3 divisions. These divisions fill VERY fast as well, fast so please do not hesitate in getting your tournament entry in ASAP!

We also plan on having a Girl's Fastpitch Division again this year. It has been a big success the last couple of years. The fastpitch divisions will begin play on Friday morning and conclude prior to the adult games starting Friday evening. An anonymous donor has offered the tournament \$5,000, with \$3,000 to be used as a cash payout to the two top teams in the Men's A/B division and \$2,000 is being donated directly to the McOuade Tournament to benefit our many charities. ASA is also offering \$2,000 to the winner to travel to the Men's A National Tournament in Oklahoma City. Last year's A/B division was a huge success and we are hoping once again that this division will fill.

This year's tournament will feature a double elimination bracket for the Women's C, Men's A/B, and the Men's C divisions. The change we made to the Men's Master's 35 & Over division last year was well received. Instead of a three game guarantee, we will be seeding the teams into two separate tournaments. The state Men's Master's Committee will assist us in seeding the teams properly. It also looks like we will have another "family" team

entered in the tournament this year. Be sure and get your registration form and payment in ASAP. PLEASE, don't procrastinate as the tournament fills very quickly. Last year we turned away over 100 teams. Don't be that manager that has to explain to their team that you forgot to send in the registration. We are hoping to match or exceed last year's record of 477 teams.

Registration forms have been mailed to all non Bismarck teams who were in last year's tournament. Bismarck managers received registration forms at their January meeting. If you missed that meeting or didn't play in the tournament last year and want to this year, or haven't received a registration form in the mail, you can print a registration form off the McQuade website which is www.mcquades.com and click on the softball link.

At this year's tournament, we will once again offer each team an opportunity to purchase an extra home run. This has been a popular feature at past tournaments. Last year we raised over \$3,000 for local charities from those teams that purchased an extra home run. More information will be included on the website and in the tournament program.

A record \$77,000 from last year's tournament was distributed to charitable organizations throughout the state and with your help and generosity we hope to be able to surpass that amount with this year's tournament. If you were a part of last year's tournament in some way, you were an important part of the tournament being able to donate all of that money to local charities and organizations—for that—Thank You So Much!

The silent auction we have during the tournament is also an area that raises a considerable amount of money for the charities. If you really want to contribute to the tournament in another way, I would like to challenge anyone to provide an item for the silent auction or contact a local business in your area to donate an item and explain the benefits of the silent auction and th4e advertising exposure to them. We estimate that close to 20,000 people will look through the silent auction items throughout the course of the weekend!

I'll remember the fastpitch game

Men's fastpitch softball history in the Fargo-Moorhead area dates back to a four-team Red River Valley tournament in 1927, won by the Crookston, MN, All Stars. The RRV was a fixture for nearly sixty years until the late 1980's when it became an ASA Class B National Qualifier. Along the way, the number of participating teams peaked at fifty during the 1963, 64, 67 and 1970 seasons. The RRV died in the mid-1990's when the number of eastern North Dakota and Western Minnesota "town teams" dwindled rapidly.

The inaugural Eugene Holm Memorial Classic Tournament was hosted in 1973 and has continued through 2010, when four teams participated.

It certainly appears our game has gone full circle during the past eight decades or so. Men's fastpitch in North Dakota and nationally has been on life support for the past several seasons and appears to be destined for extinction. A couple years ago, Minot wasn't able to attract a bus load of teams for an ASA men's 40-over National Tournament. Sure, the economy has been a factor. But the fact remains, the teams are few and far between.

At the same time, slowpitch has cornered about 99% of the players and their game appears to be flourishing. When I started playing in the West Fargo league in the midsixties, we were the only game in town. Slowpitch, since first appearing on the landscape in the early 1970's, is to be complemented for the rise in popularity of their game.

The focus of this article is not a debate about the demise and rise of the men's softball games, but rather to share more than a few reflections, memories and observations gathered from hundreds of hours around the diamond during the past forty years.

I'll Remember...

- The wooden "Hall of Fame Row" bleachers at the Fargo Mickelson Field;
- The antics of the late Bob Mc-Menany and his sidekick Dempsey;
- The "from the heels" swings of Fargo Hall of Fame players Lee Holschuh and John Lindstrom;
- Ray Clark's 20-strikeout perfect game and three no-hitters during a span of three days in 1976;
- Bob Grund, who grew up in the

shadow of Mickelson Field, returning from being seriously wounded in Vietnam, including the loss of an eye, pitching West Fargo Lepird Drywall to a State Class B ASA Championship in 1978;

- Gary Nielson, the longtime popular player and coach with the Fargo KC's, losing his battle with cancer after being exposed to Agent Orange in the jungles of Vietnam and being elected to the NDASA Hall of Fame before he passed away in 2005;
- Grand Fork's Matt's Tavern and Minot Young America advancing to the ASA Men's Major National Tournament.
- The very competitive Jamestown Tomahawk Lounge, Prairiewood Inn and Hillview Bar Teams;
- Jim Baum's late inning clutch hitting;
- The hours spent by the Lybeck family at Mickelson Park;
- Player of the 1960's decade and Hall of Fame pitching and hitting legend Tom "Rabbit" Engh;
- The late Grand Forks Hall of Fame catcher Jerry Ackerman;
 - Ollie Fiddler's changeup;
- The dominance of Fargo Pitcher Paul "Otto" Ferrie during the 1974 season and decade of the 1970's;
- The demise of NDASA "town teams" including Horace, Argusville, Buxton, Christine, Grandin, Hickson, Wild Rice, Edgeley, Southam, Selz, Harvey, Enderlin and Sabin, Comstock, Rustad and Wolverton, MN,
- Lepird Drywall outfielder Jim Thoreson's three home runs in the Commissioner Jim Hanley managed 1977 Grand Forks North Valley Championship against Steinbach, MB;
- The late umpire and friend Bobby Larson of Minot;
- Personalities of the game including Don Siverson, Jerry Day, Ken Schwinden, Jack Peterson, Rich Carrier and Doug Jacobson;
- Hall of Fame pitcher Larry "Honker" Zeadow;
- The Minot International Tournament that attracted top teams from both Canada and Montana;
- The slugging display by Winnipeg, MB, catcher Randy Dutiaume at the 1984 Fargo Holm Classic. Dutiaume had 21 hits in 30 at bats (.700) including six home runs. Dutiaume homered in three consecutive at bats against the Fargo Hall of Fame pitcher Jim Baum.



Jamestown Hall of Fame pitcher Pat Stockert shut down the Winnipeg team 7-0 in the first round and forced the Manitoba Provincial Champions to play ten games en route to the Holm Classic title;

• The transition from wooden to aircraft aluminum bats during the late 1970s and early 1980's;

- The slick fielding of Bismarck's Hall of Fame infielder Evan Lips;
- The best team nickname: "James Gang" of St. James, MN;
 - Scott Johnson's six home runs

and twelve RBI's in leading Christine, ND, to the 1982 Red River Valley Championship;

- Winnipeg, MB, pitcher Cliff Bishop's first appearance at the Holm Classic in 1977;
- The ASA Class B domination by the Devils Lake KC's;
- The 1991 ASA 40-over National runner up finish by the Bismarck-Fargo Fronteer Yellow Pages. Fronteer, armed with six pitchers: Jim Baum, Bill Keller, Pat Stockert, Otto Ferrie, Steve Wiyatt and Jim

Kapp, were the first NDASA team to reach a National Championship game. Baum and John Lindstrom were both first team All-American selections;

- My late teammates and friends, Jim "Flapper" Kapp, Mike "Mad Dog" McLeod, Loren Thompson, Bob "Wheels" Rath and Rick "Rookie" Johnson;
- The opportunity to play and coach State, Regional and National Tournament games with my two sons

Rick Fryhling

Rick Fryhling was truly a man for all seasons in North Dakota softball. He played slow pitch softball for 30 years, umpired for 20 years, managed teams for 20 years and sponsored teams for 15 to 20 years.

He also served as a player representative for the Fargo leagues and as the city Umpire in Chief and Deputy State Umpire in Chief for Southeastern North Dakota.

In his early years as a player, Rick played fast pitch softball in Minot and for a couple of years in Fargo before founding the Gateway Builders slow pitch team which he managed and for which he played. He was a great utility player who could and did play virtually every position. He also was an excellent hitter who had the ability to place the ball for base hits but also could hit for extra bases when the situation demanded. A good base runner who was exceptionally fast it was not uncommon for him to hit an inside the park homer. In addition to his softball activities, he also coached little league baseball and softball teams. Rick was active in the Fargo Church League as well serving on the Board of Directors and as president of the league for many years.

As a registered ASA umpire, he worked a number of state tournaments and was selected to umpire in three national championship tournaments in 1996, 1998 and 2000.

Gail Ingwalson

Another of the many softball enthusiasts who involve themselves in several aspects of the game, Ingwalson played the game for 40 years, has been a long time coach and manager and served on the Grand Forks Board of Directors and as Supervisor of the Youth Softball program in Grand Forks.

Her playing career began at the age of 12 when she and her dad started a girl's team in Buxton which competed at the Class B level.

After high school graduation, Gail played basketball and fast pitch softball for the University of North Dakota. Her freshman years she was the starting shortstop and played that position or first base throughout her four year career. Her approximate batting average was .300. She was the team captain her junior and senior year and the teams most valuable player her senior year.

Gail has played and coached at the state level throughout her 40 year career from Class A through Class D level. She estimates her lifetime batting average at about .375 which is extremely conservative. She has competed in 78 state tournaments as a player (45 women's 15 Co-Ed and 18 Old Pro)

Gail has also coached Junior Olympic teams and in 1979 was hired to coach in the youth softball program in Grand Forks. In 1980 she was promoted to supervisor of the Grand Forks Park District youth softball program and she continued in that capacity until 1998. She also served on the Board for the Grand Forks Softball Association for 20 years and was the president of that group for nine years.

Harold Wilkens

Nominated and considered primarily as a team sponsor, Harold Wilkens also played the game of softball for many years. As sponsor and team manager, he would be called on to fill in many times and at various positions. His teams Harold's Skelly of Center were well known and respected in the softball community around the state.

Harold started sponsoring his team in 1973 when he owned the Skelly gas station in Center. He sold his business in 1984 but because of his love of the game of softball continued to sponsor his team until 1999 when he turned 70 years of age.

His teams won the state championship in 1985 in the Old Pro 35 and Over category and in 1997 as the Class D West champion. His team also competed in one regional tournament in Pierre, South Dakota finishing in third place in the Men's Division IV Class.

Without dedicated sponsors like Harold Wilkens the great sport of softball could not exist and flourish as it has over the past many years. His dedication to his teams and to the game are unmatched.

Minot Legend and ASA Hall of Famer dies

Rueben Ookie Hammond, 93, Minot, and former director of the Minot Recreation Commission died on Wednesday, December 29, 2010 in a Minot hospital.

Rueben Edward Ookie Hammond was born on May 3, 1917 in Westhope, North Dakota. He was adopted at an early age by John Tucker J.T. and Gina (Nickelson) Hammond. He was raised in Westhope and in Minot where he and his adoptive mother moved in 1920 following his adoptive fathers death in 1918. His mother was an immigrant from Norway who supported her son by washing clothes and house cleaning. She became employed as a custodian at Harrison School on the campus of Minot State University in 1929 and continued in that capacity until her retirement in 1953. She lived to be more than 100 years old and was a widow for 76 of those years. Her strong faith in God and her work ethic left an indelible image on Ookie.

In addition, he had received commendations from the Minot Air Force Base, Mary College, Bishop Ryan High School and the City of Minot.

His passion for people of all ages and ethnic backgrounds earned him many lifelong friendships. He was a very loving son, husband, father, grandfather and great-grandfather. He was a wonderful man who will be missed by many.

A sample from the 2011 Umpire Test

Players must carry picture ID at tourneys

North Dakota ASA will continue to follow the National Rule which requires that all players carry a current picture ID with signature at all tournaments. After June 15th, managers must also carry a copy of the team roster.

Spot checks will be made. Any person playing without proper ID will face suspension as do his teammates and/or manager. Games will be forfeited at that time. The NDASA executive committee meeting last fall adopted the following rules in regard to picture ID:

When questioned, if the player does not have a picture ID on his person, he or she will be given five minutes to present it.

The player is ineligible until a picture ID has been presented.

The players in violation will be ejected from the game if no ID is available.

The game is not forfeited.

The team can replace the players if they have substitutions.

If the ejection brings the team number down to nine, the team will be allowed to continue with an out in the batting position of the players ejected. This is similar to the injury rule.

If the player turns out to be an illegal player, the present rules for the use of illegal players will be in effect.

MANAGERS—be sure all your players have picture identification so they will not be embarrassed and lose their right to play.

2010 ASA Equipment Committee Review

Editor's Note: The following is a review of the Equipment Committee activities during 2010 prepared by Dick Gulmon, chairman of this important national committee. Much of the committee's emphasis was on the testing and acceptance of a new ball which will have a reduced batted ball speed which in turn will increase the reaction time of the defensive players.

In addition this new ball will be less affected by temperature extremes, either hot or cold. The committee is continuing it's efforts to make our game safer while retaining it's competitive aspects.

In the past year the Equipment Committee and staff spent a considerable amount of time on the development and approval process of a new ball for the slow pitch game. This process involved extensive lab and field testing with numerous bat and ball combinations.

The development of a new ball certification also involved reaching out to ball manufacturers to provide a prototype ball that was playable, reduce injury to players upon impact, temper bat performance and be less affected by weather extremes. This process started in the lab at WSU and continued through field testing in Pullman,

Washington last May by members of the Equipment Committee.

The Trackman radar system was used for the field testing in Pullman. The Trackman technology was made possible by a partnership developed by ASA, WSU Lab, NCAA, and NFHS for the Trackman technology has proven to be essential to the decision making process in monitoring game conditions, field standards and research. Increasing our understanding of the game will qualify how rule changes effect play, including field dimensions, softballs, bats and temperature. While in Pullman, the committee toured the testing lab at WSU with Dr. Lloyd smith and noted many new improvements since the committee's last visit to the site. Members traveled to a local ballpark to observe and participate in field testing experiments with three (3) prototype balls.

Specific bats and balls were selected to be tested using slow pitch players of varying skills. Hitting performance data was collected using the new Trackman radar system.

The committee also reviewed a number of items such as bat confiscation procedures, issues related to altered bats, bat testing machines, protective equipment, bases, data

regarding the pitch height change in slow pitch and potential new products for the game of softball.

Work at the WSU Lab by Dr. Smith this past year included the following areas:

- Ball size and weight compared the effect of ball size & weight on hit distance, hit speed, pitcher reaction time, and impact force.
- Pitch height compared the effect of pitch height, and pitcher distance on the hit speed.
- Trackman-Dr. Smith visited a facility in Denmark who manufactured the Trackman, assisted the Pullman field study as well as tracked tournaments such as WCWS, World Cup, Men's D, Hooters Championship Series and High School GFP at Hall of Fame Stadium.
- Ball Temperature compared the effect of ball temperature on COR and Dynamic Stiffness.

Dr. Smith's work in each of these areas and insight as to the science of the game proves to be invaluable to the Equipment Committee's work.

After considerable lab testing, field testing, as well as the cooperation of ball manufacturers, the Equipment Committee is pleased to bring a rule change to the council this year for an additional ball cer-

tification for the slow pitch game. Field & Lab test data has provided the committee with the following results to propose a 52/300 ball for certification effective 1/1/11.

- Reduced BBS/Increased Reaction Time
- Less effected by temperature changes, such as extreme heat or cold.
- Significant reduction in impact force on the body when struck with a thrown or batted ball.
- Charting of games was also done again this year at the Hooters Championship series. BBS was also measured at all levels of play with the Trackman technology.

Some of the projects for the Equipment Committee and Dr. Smiths lab in 2011 are:

- Bat and Ball Compliance
- Continued review of potential new products
- Continue to utilize the Trackman at major tournaments and develop data base of playing conditions, evaluate accuracy of speed and distance measurements, and extract ball left and drag from tracked data. Field test with the Trackman will compare lab and field performance of softball bats of various levels of performance.

As in the past, it is the duty of the Equipment Committee to make the very best decisions possible for the game of softball, based on scientific data with regards to future bat and ball combinations, and related equipment that will uphold the integrity of the game.

State Umpire in Chief Mike Wolf of Bismarck was slated to attend but last minute responsibilities at his work place prevented his attendance.

The event opened on Thursday evening, February 3, with sessions designed to provide training for umpires who are assuming responsibilities as Umpires in Chief for their state or metro area and also a session for those Umpires who are or want to be an Umpire in Chief at a National Championship tournament. On Friday and Saturday, breakout sessions were presented by members of the National Umpire Staff. These sessions included presentations on understanding the rules on players and substitutes, batting and pitching, umpires mechanics and equipment issues. In addition, a lengthy presentation on Obstruction and Interference provided lively discussions and pertinent information.

The Clinic wrapped up with a banquet on Saturday night and awards were presented at that time to an outstanding umpire from each Region. North Dakota UIC Mike Wolf was the recipient of the award from the Northern Region. A separate story on his award appears elsewhere in this issue.

2011 ASA softball playing rule changes with comments

Rule 2, Section 1 Table: The base distance for Men's Class A and Class B Slow Pitch classification shall be 70 feet.

Comment: Allows for more defensive plays in our upper classifications of Men's Slow Pitch. **Rule 2, Section 3H:** The double base shall be used at first base in all divisions of play. The base is 15x20 inches and both sides of the double base, white and contrasting color, shall

be of equal thickness. (5" max). Comment: This clarifies that both sides of the double base must be equal in height.

Rule 3, Section 1D: The safety grip can be made of cork, tape or other synthetic material and must be permanently attached and cover the handle region of the bat. No bare metal may be exposed in the area covered by safety grip. It shall not be less than 10 inches and not more than 15 inches. Any attachment such as a molded finger grip, flare cone, or choke up devise must be attached to the grip with safety tape. Resin, pine tar, or spray substances are permissible on the safety grip only. Comment: Better defines the safety grip of a

legal bat. Rule 3, Section 1H: An ASA official bat's characteristics shall remain fixed at the time of manufacture and may not be altered in any way other than specifically provided for in (Rule 3, Section 1) or as specifically approved by the ASA. Approved bats shall be considered altered if they are rolled, shaved, repainted, weighted or modified to change their characteristics from that produced by the manufacturer. Identifying the bat by means of laser marking, engraving, or painting the name or number of the player will not make the bat an altered bat. Comment: This better defines an altered bat and allows for engraving to be part of the identification process.

Rule 3, Section 3A: The ball must have an ASA approved Certification Mark and not appear on the ASA non Approved Ball List. Comment: There will be balls with certification marks that will be added to a non approved ball list. This clarifies that the balls on this list will no longer be approved.

Rule 3, Section 3E (3): A yellow cover red stitch 12" ball with as follows: Size: At least 11.875 in.; Weight: at least 6.250 oz.; COR .520 max; Compression: 300.0 lbs. max and Dynamic Stiffness: 5500.0 lbs. Max. Comments: Allows for an additional 12" ball for the Slow Pitch Classification of play that is less temperature sensitive, reduces batted ball speed, and increases player reaction time.

Rule 3, Section 6: Exception: Men's Class E/Rec: The only uniform requirement is matching shirts with numbers.

Comment: Allows the uniform code for E/Rec Classification to be less stringent.

Rule 4, Section 1C (3): If discovered using the wrong number of females or males in the outfield and brought to the umpire's attention by the offended team:

After a pitch legal or illegal or play made, EF-FECT: All action stands.

Before the next pitch legal or illegal or play made,

Before the defense has left the field, Before the umpires have left the field of paly, EFFECT: b, c and d

If the batter hits the ball and reaches first base safely, and all other runners have advanced at least one base. All action of the batted ball stands.

If all runners, including the batter runner, do not advance at least one base. The manager has the option of taking the result of the play, or awards the batter first base and advances all runners, if forced.

Comment: This adds a penalty for the defensive team not playing the right number of males and or females in the outfield and infield.

Rule 6, Section 3K (2): (Modified Pitch) The pivot foot must drag and not lose contact with the ground.

Comment: This matches the foot requirements for 10 man with 9 man in the rule book.

Rule 7, Section 3B: (Adult Slow Pitch Only except Seniors) The batter shall assume a one ball, one strike count upon entering the batter's box

Comment: This removes the Master's Slow Pitch classification from the exception and they will now start with a one and one count.

Rule 10, Section 5D: The approved navy ball bag(s) with ASA letters to be worn with the Navy or Fechheimer gray slacks; or the gray ball bag(s) with the ASA letters may be worn with the Fechheimer gray slacks.

Comment: Clarifies the uniform rule to allow the

gray ball bag with the ASA letters to be worn. **Rule 10, Section 5H:** The plate umpire must wear a black or silver mask, with black or tan padding and black throat protector. Comments: This allows for a silver colored mask to be worn by the plate umpire.

Article: 310 C 02 a b Delete additional words and add

02. **Use of Assistant Umpires-in-Chief.** The use of an Assistant Umpite-in-Chief shall be governed as follows:

a. If a National Championship Final has 40 or more teams.

b. If a National Championship Final plays on more than four (4) fields.

Comments: To assist the National Championship UIC in administering the umpire program.

Article: 403 A 01 c Amendments to the ASA Code

c. At least fifteen (15) days prior to the start of the annual meeting, the Executive Director shall mail **and/or electronically** mail, to each member of the Council written notice of all properly submitted proposed amendments.

Comments: Gives the option to email the code proposals out to the council.

Article: 403 B 01 c Amendments to the ASA Playing Rules

c. At least fifteen (15) days prior to the start of the annual meeting, the Executive Director shall mail **and/or electronically** mail, to each member of the Council written notice of all properly submitted proposed amendments.

Comments: Gives the option to email the code proposals out to the council.

Article: 501 D 06 Industrial Qualifications. The ASA shall conduct championship tournaments for industral or all-employee teams. Industrial team rosters must have the eligibility form attached that verifies employment requirements.

Comments: Adds a verification form for Industrial teams.

Article: 501 D 07 Church Qualifications. The ASA shall conduct championship tournaments for industral or all-employee teams. Church team rosters must have the eligibility form attached that verifies employment requirements.

Comments: Adds a verification form for Church teams.

Article: 503 A 01 New EXCEPTION.

EXCEPTION: (Adult only) If two local associations combine berths and/or championship play, pick-up players may come from either local association with the approval of both commissioners.

Comments: Allows adult pick-up players from associations who combine berths or tournaments to award berths.

Article: 505 B 01 Time Limitations. Suspension complaints must be filed with the Commissioner in whose association the offense is alleged to have occured or the commissioner in who association registered the player or team, within at least one of the following time restrictions: within six (6) months of the date of the alleged violation; ot within six (6) months of the complaint's discovery of the alleged violation, so long as the complaint was not unreasonable in failing to discover the alleged violation. Comments: Changes the time limitations.

Article: 505 B 02 Hearing. Prior to suspension, the accused must be given an opportunity for a hearing by the commissioner in whose jurisdiction the violation took place. The commissioner may appoint a deputy or district commissioner, an officer or an official of the local association or any other disinterested party to conduct the hearing in their place. Notwithstanding the prior sentence or other provisions of Article 505 of this Code, for purpose of addressing extensuating circumstanves, ASA Executive Director and or any ASA Commissioner shall have the authority to issue and interim suspension pending a hearing. In cases of an interim suspension, an initial hearing on the matter must be scheduled within fifteen (15) days from the first day of the interim suspension. An interim suspension shall have the same effect as a suspension.

Comments: Allows the Executive Director/Commissioner to immediately suspend a player/team on an interim basis.

Article: 505 B 04 New - re-number

issue a stay pending appeal.

Hearing Process Interference Penalties. No person may interfere with the ASA hearing process under this Article 505 or any other ASA Code article. Any person who harasses, threatens, tampers with, or intimidates any member of any hearing panel, any ASA administrator or official, or any potential hearing witness, or who attempts to do so, shall be subject to discipline under this ASA Code, incuding suspension for such actions. Any attempts to interfere with ASA's hearing process shall constitute independent grounds for discipline against that person.

Comments: To put penalties in the code for interfering with ASA hearings.

Article: 505 B 05 Right of Appeal. Following the decision of the local association commissioner, the accused or any person claiming that an act of suspension was or was not committed may appeal in writing within fourteen (14) days to the Executive Director or their designee whose decision shall be final. The Executive Director must render a decision on any appeal within fourteen (14) days. **The Executive Director shall have the authority in extentuating circumstance to**

Comments: Gives the Executive Director the authority to issue a stay pending an appeal.

Article: 506 A 07 DIVISIONS AND CLASSIFICATIONS OF CHAMPIONSHIP PLAY DEFINED.

A. The ASA recognizes the following divisions and classifications of championship play. Each local association shall establish a classification code to determine team and/or player classification for championship play in the following divisions:

DIVISIONS CLASSIFICATIONS

07. Men's (09) Man Modified Pitch

Comments: Removes the Class A and Major division of the 9 man Modified Pitch.

Article: 507 G NEW National Adult Fast Pitch Pitchers Classification Board.

01. Responsibilities. The National Pitcher Classification Board will oversee all aspects of the adult fast pitch pitcher classification. The board will create procedures regarding classification.

a. The Board will consist of five people, one representative from each territory plus one at-large member, as shown:

- Eastern Territory
- Northern Territory
- Southern Territory
- Western Territory
- At large member to be assigned by ASA President.

Note: If a territory cannot elect a representative, then the president will fill the vacancy by appointment.

b. Each territory representative shall name a territorial subcommittee comprised of no less than five and no more than 9 people from their territory. Local association representatives will be assigned in conjunction with the Association Commissioner.

02. Duties.

a. Each territory shall create and maintain a fast pitch pitcher classification.

b. This board is to uphold the national pitchers list and classification strategy. c. This board in concert with the National ASA Office staff will oversee and maintain a national pitchers classification list.

d. This board in concert with the National ASA Office staff will communicate with the tournament directors of ASA National Championships to ensure all pitchers participating in ASA Fast Pitch events are within the established procedures.

e. This board will also seek out further information by cintracting local commissioners, player representatives, district commissioners, league directors, and tournament directors to acquire the best and most recent information on fast pitch pitchers.

03. Rules

a. Male and Female pitchers that are classified Major Fast Pitch by the local association in which they reside must remain in that classification until changed by the same local association.

b. Any Men's Class B or C Fast Pitch pitcher who earns First Team All Tournament, MVP or outstanding pitcher awards and whose team is reclassified pursuant to Article 507 (G) (02) or Article 507 (G) (03), must pitch at the higher classification their next ASA playing season.

c. In all adult Fast Pitch, no USA National Team Member may participate below the Class A Classification.

d. All Men's Fast Pitch players and/or teams are eligible to participate in the Men's Major Fast Pitch National Championship and retain their eligibility for their original classification in Championship Play.

e. Men's Major Fast Pitch Players will be classified by a restricted fast pitch players list. The restricted fast pitch players list will be available on the ASA website and this list will be updated, modified and/or revised on a regular and continuous basis, but will be finalized by July 1 each year for the current year's National Championship Finals. the players on this list are ineligible to participate in the Men's Class A, B, and C Fast Pitch classification. Any appeals regarding this list can be made through the ASA National Office to the Fast Pitch Classification Board.

04. Classification Appeal. Pitchers classified in accordance with this article have the right to appeal their classification after participating at the higher classification. The appeal must be submitted in writing to the team's local commissioner and should include game results and reason for appeal. The local commissioner shall evaluate the information presented and forward the appeal with their recommendation to the National Adult Fast Pitch Pitcher's Board. The National Adult Fast Pitch Pitchers Board shall review the information presented and make a determination on the appeal.

Comments: Adds a National Fast Pitch Pitchers Classification Board.

Article: 507 G 01 Mandatory Player Classification. Starting January 1 each year will start a player appeal process where each player can submit an appeal to have their player rating dropped. This process ends August 1 and at that time appeals will not be accepted until January. We have taken our team, procedures and based it on the ASA Code in which a team could have 3 Mandatory players from the next higher division on their roster. We consider our list equal to Mandatory classified players. With the player classification system that we have in place helps create a fair and level playing field for all of out teams not only at a local but also at a national level. Below are the procedures that we use on how to classify a team. Players on the ASA Restricted List can only participate in the Men's A or Coed Open Programs. A Player may have a + designation, this player cannot play down a class.

Comments: Extends the process for appeals one month and adds a + designation wich will not allow players to play down to a lower classification.

Article: 507 G 03 b Returning Players. A team that has a combination of four or more players on a roster, including pick-ups, from a team or teams subject to mandatory reclassification and/or restricted classification must maintain the classification as assigned by the mandatory classification rule.

EXCEPTION: Players that have successfully appealed and been granted a reclassification shall not be counted towards the four player rule for a returing team.

Article: 507 G 04 New

04. Men's Masters 35-Over, 40-Over, and 45-Over Slow Pitch. Teams playing in the Men's Masters 35-Over, 40-Over, and 45-Over Slow Pitch play shall not have more than two (2) players, or no players from the Restricted Player List and four class A rated players.

Comments: To put restrictions on the amount of upper level players that can participate in the Masters Division.

Article: 508 A Local Association Championships. Local Associations championship play at the state or metro championship, must follow ASA Code requirements except that Local Associations rules may be enacted for: Run rules, time limits, uniforms (except that a minimum a like shirt with numbers on the back), home run rules, stealing, metal cleats and fence distances. Local associations may not conduct championship play tournaments in locations outside of their association's boundaries without permission from that local association's commissioner. Local Associations may conduct JO qualifying tournaments for the follwing years championship play. Teams that participate in these

tournaments must use age eligible players for the year the championship play will be played and must

meet the returning team requirement to maintain their berth. Comments: Allows Local Associations the opportunity to enact local rules for championship play.

Article: 509 Regional's National Qualifiers, and Territorial Gold Qualifiers must be scheduled between a Friday and Sunday.

Comments: Requires that these events are played on a weekend.

Article: 509 C 02 g Women's Major, Class A and B Fast Pitch. These National Championship Finals shall be scheduled on the weekend that includes the **second** Saturday in August and shall be scheduled for a minimum of four days, and shall be held at one site. Comments: Changes the dates of the Women's Fast Pitch Championships.

Article: 509 C 04 d Delete 504 C 04 D and re-number

Girls' ASA Class A and B Fast Pitch (all ages). These National Championship Finals shall be scheduled by the territory in which the tournament takes place, but must be scheduled between the weekend that contains the third Saturday of July and the weekend that includes the second Saturday of August and may have the option of commencing no earlier than Monday. Opening ceremonies may be held on that Monday. These championships are scheduled for a maximum of seven days. Comments: Adds flexibility to the dates of the Girls Class A Fast Pitch National Championships.

Article: 509 C 04 f Girls' ASA Gold 18-Under Fast Pitch. This National Championship Final shall be scheduled and completed on the weekend that includes the **last** Saturday in **July** and not be held more than seven (7) days. This event won't have an opening ceremonies event and the managers meeting can't be scheduled prior to 6:00 PM on the prior Sunday. Comments: Moves the Gold National Championship up one weekend.

Article: 510 A A. Assessment Fees. Each team participating in ASA Championship play, not including state/metro championships shall be assessed an ASA fee (See Article 606 (D) Tournament Assessment Fees and Summary of Tournament Assessment Fees) of this Code.

Comments: Removes the reference of how much assessment fees are because they are listed in Article 606.

Article: 510 D Entry Deadlines. An official team entry form and proper entry fee must be submitted to the tournament director of all National Championship Finals seven (7) days prior to commencement of the tournament.

Comments: States that entry form and fee must be submitted 7 days prior to the start of a championship.

Article: 510 M 06 Altered Bat. Any person discovered in possession of an altered bat at or near the facility or grounds of a softball competition in which such equipment is not permitted to be used shall be subject to discipline pursuant to Article 505. ASA shall have the right to take possession of a bat that is, in the sole direction of the official, reasonable suspected to be an altered bat, then the player shall surrender ownership of the altered bat to ASA; otherwise a bat of equal or greater value or a monetary equivalent, in the sole direction of ASA, shall be returned to the owner of the subject bat. A team that is discovered to have within its possession or control an altered bat may be suspended from further tournament competition.

Comments: Better defines Altered Bat.

Article: 511 A Deletes references of Bracket protection with Championships that have pool play.

Comments: In tournaments with Pool Play remove all reference to protection in bracket play.

Article: 513 MPreviously Qualified. Junior Olympic Teams which have previously qualified for a National Championship Final may compete in other National Qualifiers. If a previously qualified team wins another berth from a National Qualifiers. The highest finishing team without a berth will qualify.

Exception: Gold teams that have qualified for the Gold National Championship cannot play in the Gold National Qualifier.

Comments: Eliminates Gold Qualified teams from participating in the Gold National Qualifier.

Article: 516 G Girls' Class A USA/ASA Fast Pitch National Championship Finals. 18, 16, 14, 12, 10-Under Defending Champion Runner-Up **Host Teams** 2 Hall of Fame - Not Applicable For 10-Under 8 **National Qualifiers** 15 **East National Qualifier West National Qualifier** Regional Berths - Two Teams from Each Region 30 Returning Teams from the previous year's USA/ASA National Championship Finals and ASA National Championship Finals 0-16

Association Berths based on previous year's Girl's Fast Pitch registrations: Associations registering 201-999 teams, receives one(1) berth, for associations increment of 500 team registrations. As an example,

Comments: Rotates Gold into Oklahoma City every other year.

Article: 602 H 12 EFFECTIVE 2013

The Men's Masters Slow Pitch 30-Over and 45-Over will be played at the same site.

Comments: Places the Men's Masters Slow Pitch 35-Over and 45-Over in the same location.

Article: 602 H 13 There will be at least one USA/ASA Junior Olympic National Championship Finals in each Territory.

 $\label{lem:comments: New process for awarding USA-ASA Junior Olympic National Championship Finals with at least one championship in each territory.$

Article: 602 S Pre-Tournament Fact Sheet. Host city must supply complete information for pre-tournament fact at the conclusion of the council meeting in the year prior to the championship. Failure to do so without a reasonable explanation may result in host city forfeiting right to bid on a National Championship Final for a period of one year and then only with approval of the ASA Executive Director.

Comments: Sets deadline for when the Pre-tournament fact sheet is due.

Article: 602 U New: A National Championship cannot be cancelled without prior approval from the Executive Director.

Comments: Establishes a process for canceling a National Championship.

Article: 603 B 01 Umpire Expense. Umpire expenses must include the following:

01. Game fees for adult fast pitch shall be **a minimum of** \$25.00 per game; game fees for youth fast pitch shall be **a minimum of** \$25.00 per game; Men's Major Fast Pitch shall be **a minimum of** \$25.00 per game and Junior Olympic GOLD fast pitch game fees shall be **a minimum of** \$25.00 per game. The number of umpires to be assigned per game is addressed in Comments: Sets a minimum game fee for fast umpires.

Article: 603 B 03 03. Housing, local transportation for UIC and \$100.00 per diem/per day for the tournament umpire-in-chief. The UIC shall arrive one day prior to the scheduled opening day of the Championship.

Comments: Establishes when a UIC should arrive at a National Championship.

Article: 603 B 05 New

05. The UIC and Assistant UIC (if assigned) may share a room if deemed necessary by the Tournament Host Committee.

Casual profanity rule defined

Casual profanity pertains to expletives "not directed at the umpires or opposing players, but most likely at the players uttering them as a vent to frustration. This type of profanity is penalized by "OUTS" being declared against the offensive or defensive teams, whichever is guilty of the violations. The above "OUTS" will be treated on a delayed, dead ball situation. Profanity directed at others, especially umpires, will still result in ejection.

Let's say a team has the bases loaded and the batter pops up to the infield. Immediately he lets out a profanity (fill in your favorite).

What happens if the fielder catches the ball? The batter can't be called "OUT" because he already is. Therefore, the next batter is out. If the batter would be first up the next inning, that spot will be an OUT. That's how the penalty is enforced.

If a defensive player "boots" the ball or drops the ball and utters a profanity where it can be heard by the people in the stand the defense is penalized by having their first batter called out when they come to bat. This is the only aspect of the rule, along with carry-over of the third out enforcement on the offensive team, where the rule will have to be enforced at a later time

Profanity directed at others, especially umpires, will still result in ejection. If a player is called out on a bang-bang players at first and he utters a word under his breath as he runs by the umpires at first, or curses under his breath because of this poor hit as he was thrown out at first, the CASUAL PROFANITY RULE will not be enforced. That's because no one but the umpire, and maybe the first baseman has heard him.

THE CASUAL PROFANITY RULE provides a lesser penalty for the gray area between accepted conduct and situations where the offender must be ejected. It has been found that the players police themselves and each other after this happens a couple of times and it has worked for the betterment of softball. It gets players to clean up their act. Early in the year, umpires, in pregame conference, should warn both managers that the CASUAL PROFANITY RULE applies. Failure to do so does not preclude the penalty being enforced. After June 15, this is not required at pre-game conference as all teams should be aware of the rule.

Bismarck to host Men's National

Labor Day tournament features Men's Class C

The Men's Class C Northern National tournament returns to Bismarck over the Labor Day weekend. Bismarck was the successful bidder for the tournament during the National Council meeting in Reno, Nevada in the fall of 2009.

Five cities were vying for the tournament including two Minnesota cities, Rochester and Moorhead. Topeka, Kansas and South Bend, Indiana also bid for the tournament. National tournaments are bid two years in advance to allow host cities time to properly prepare for the national events.

Bismarck has held a number of successful national tournament events since their initial

attempt in 1989. Mandan was awarded the Men's 40 and Over for 2012 at the National Council meeting in Shreveport, Louisiana in November, 2010.

The Northern National Class C to be held in Bismarck will be limited to teams from the Northern Territory which includes 13 states from the Dakotas to Indiana and Kentucky. A tournament committee of veteran softball enthusiasts will be formed to take care of the many details involved in running a successful national softball tournament.

North Dakota cities have been successful in attracting national events in Minot, Mandan, Grand Forks as well as Bismarck.

Watertown, S.D. Hosts 10 Through 18 Year Olds

Watertown, South Dakota will host the Junior Olympic Slow Pitch National Championship for ages 10 and under, 12 and under, 14 and under, 16 and under and 18 and under July 28 through 31. What an opportunity for teams from North Dakota to participate in an ASA National Championship event.

Several North Dakota cities located in the southeastern half of North Dakota will be within easy driving distance of this tournament. The cities of Fairmount, Hankinson,

Lidgerwood, Milnor, Lisbon, Napoleon, Valley City, Jamestown, Harvey, Horace and Wahpeton all fielded girl's slow pitch teams in the state tournament last year and all would be eligible for this national championship event as long as they registered ASA and play in this year's state tournament.

Masters Committee Report

November 30, 2010

Following is the long awaited Masters Committee report.

1. Allow one courtesy runner per inning in Masters 35 (adopt same rule for 35 as presently used in Masters 40).

This is a request from the Masters 35 team managers.

2. Allow pickup players in Masters 35/40 State Tournaments.

a) Maximum 2 pick-up players

b) Maximum 12 players (including pick-ups)c) Pick-up players must be age qualified

and rostered NDASA players
d) Masters 35 Div I – Teams may pick up

from any class
35 Div. II – Pick-up players must be Rec

35 Div III – Pick-up players must be Rec 3 or Rec 4 only

Masters 40 Div I – any class

40 Div II – Pick-up players Rec 2 or below Pick-up players request came from the team managers. Our committee recommends a pick-up player form be developed that must be turned in prior to a team's initial game in the tournament.

3. Team managers requested a set classification system for Masters divisions.

a) Masters 35 Div I teams will be any team with 2 or more lettered (A-D) players.

b) Masters 35 Div II will be allowed one (1) lettered player.

c) Masters 35 Div III – no lettered players allowed

Masters 40

a) Any team with a lettered player will be Div I.

b) No lettered players in Div II

Masters Committee requests all rosters be available for the Masters classification meeting in July.

4. Allow 50 & over players to play both the wood bat 50 and Rec 3 State Tournaments, even if they are the same weekend.

This has been requested by both the Master 50 teams and some Rec 3 team managers.

- 5. ASA bat list will continue to be used as the determination of what is or is not a single wall bat.
- 6. Committee recommends Masters 60 State Tournament remain in Mandan, until tournament numbers increase.

7. State Tournament site recommendations.

Masters 40/Masters 60 Mandan Masters 35 Fargo Masters 50 Jamestown Wood Bat Mandan

In a non-masters item, we discussed the ongoing issue of upper class players and Rec divisions of play. Our discussion came out with these suggestions.

1) Players not be allowed to play down more than two classes. With this change C players could not play below Rec I, D players could not play below Rec 2, and Rec I players below Rec 3. This change would make Rec 3 & 4 truly recreational softball.

2) In conjunction with this change, we also suggest moving the Div I/II/III tournament back one week, playing it the same weekend as the Rec 3. The upper class teams have requested this change, making the state tournament closer to Nationals. It would allow the upper class players to play in the Rec I/II State Tournaments and eliminate them from the Rec 3.
