- President / VP Report sent electronically
 - Attorney Rick Carter present to speak about insurance coverage
 - USA Hockey has two insurance policies. 1. General Liability 2. D&O Insurance. However, AAHA is not named as the primary insured. Also, we do not have access to see the policies and what is covered.
 - C&A Policy for AAHA is \$1500 annually for D&O policy with general liability insurance strongly recommended for member organizations. This is the policy controlled by your broker and is primary policy and USA Hockey policies are secondary. There is a specific endorsement to state that C&A is primary and USA Hockey is secondary.
 - T. Reckell announced former Association Administrator Tammy Bartlet has not returned any files or AAHA property to the BOD. Request to have Rick Carter draft a letter requesting the files and property be returned.
 - Motion to craft and send letter to Tammy Bartlet requesting the

 - Reminder to have safe sport certification and background locker room monitors cleared. Applies to all ages under 18. Monitors must be an arms length away in open door or in the locker room.

 - Motion to approve by B. Urban and seconded by J. Rogers. Motion Carries. Unanimous
 - Proposal from Tier Committee to change 13.2.5 and 13.3.4 to change the first tie-breaker to most wins. Will vote on at next meeting.

- Would like to recognize the officials of AZ for writing up the best incident reports across the nation. Also, they do a great job showing up for the disciplinary committee meetings
- Rules Committee Meeting Discussion from last week's meeting (Highlights from the over 200 proposed changes)
 - Recommended to defeat proposal that changes how teams may roster from 18 players and 2 goalies to 19 skaters and 1 goalie
 - Minor Penalties further discussion to occur
 - Reduce the penalty to 1 min and 30 sec for 15 min periods.
 - Penalties will be based on period length
 - Aggressive Suspension
 - Recommend to approve adding grabbing and holding the facemask as an aggressive suspension
 - Recommend to add language regarding racial or ethnic slurs
 - Recommend to remove body checking at 14U level
 - Vote was 9-6 to recommend for approval
 - More discussion to occur
 - Recommend to approve all face-offs must be conducted at one of the nine face off spots
 - Recommend to approve the ability to eliminate the idea of a short-handed team to be able to ice the puck
 - Massachusetts and Alaska have done pilot programs with good success
- Mite Committee Report sent electronically
 - Mite Committee created a standardization of rules for all mite jamborees. A recent association did not follow a rule at a recent jamboree and will be investigated further. May consider to add language for penalties if rules are not followed
 - Tucson Participated at recent mite jamboree at Ice Den Scottsdale
 - NHL Mobile tour to consider hosting an outdoor street hockey jamboree on Jan 7 and 8. Will work with the Arizona Coyotes to create this at Sun Devil Stadium or at Gila River Arena
- Officiating Report sent electronically
 - Game Fees
 - Will establish a cycle and evaluate every three years. For example: year 1 = travel fees, year 2 = house fees and year 3 = adult fees.
 - Will disseminate a new proposed travel referee fee schedule that is equalized by the next AAHA Board meeting
 - Request by G. Pashkowski to include State Play-downs in the new schedule
 - Scorekeepers C. Zorza
 - RMD Referee in Chief recommends scorekeepers do not fall under the officiating and association should be responsible for their own scorekeepers. AHOA Board

has majority that feels the same. Referees are on-ice officials and scorekeepers are considered off-ice officials. AHOA does not have the resources to properly train and organize the scorekeepers.

- J. Rogers stated the idea was consistency in training to make sure the games were managed the same way.
- C. Hampton concerned over the scheduling for AHSHA
- E. Gavrilles reminded AHOA that AAHA has approved a motion to have one organization manage the officials and scorekeepers.
- C. Zorza states no set training program for scorekeepers and majority of complaints are scorekeeper related.
 Unsure of how many scorekeepers are in the organization.
- Increase in players removing the ear protection for games and it is a penalty. Remind coaches to check ear protection
