      - 2. The main concern was the way in which this was communicated. Parents did not feel this came from the Coordinator but more from Goalie Coach and another non-Board member.
      - 3. Due to prior actions the "non-Board member" mentioned above is charged with Coordination of the Pee Wee level. Parents were unaware
  - c. Ice time (Full Ice) not equal amongst the Pee Wee A and B
    - i. Parents brought a concern with unequal ice time being scheduled
    - ii. Coordinator will work on improving this situation
