PROTEST PROCEDURE

1. MUST BE OF A TECHNICAL RULE VIOLATION, NOT A JUDGEMENT SITUATION.
 2. THE PROTEST MUST BE SUBMITTED TO THE TOURNAMENT TECHNICAL COMMITTEE (listed below) WITHIN THIRTY (30) MINUTES OF THE END OF THE BOUT OR VIOLATION IN QUESTION. THE PROTEST CAN BE HEARD AND RULED UPON BY ANY THREE (3) OF THE FIVE (5) MEMBERS.
 3. THE PROTEST MUST HAVE IN WRITING THE FOLLOWING INFORMATION:
 - A) Names of contesting athletes involved
 - B) Mat Number or Identification thereof
 - C) Names of any or all officials assigned to the violation in question
 - D) Nature of protest - (Rule identification by code number if possible)
 - E) Desired settlement or adjustment
 4. THE PROTEST MUST BE ACCOMPANIED BY A CASH DEPOSIT OF: \$_____ FOR ALL AGE DIVISIONS - PEE-WEE THROUGH VETERAN. IF PROTEST IS DENIED FORFEITURE OF DEPOSIT. IF PROTEST IS UPHOLD DEPOSIT WILL BE RETURNED.
 5. AN UNAPPEALABLE FINAL DECISION WILL BE RENDERED BY THE TOURNAMENT TECHNICAL COMMITTEE, AS SOON AS POSSIBLE, BEFORE THE NEXT ROUND OR SESSION WHENEVER PRACTICAL.
