<b>NorCal updates</b>	<p>NorCal has made changes for next year. Below are some changes that are not confirmed but were briefly discussed. Dave Curtis will send out NorCal updates via email.</p> <ul style="list-style-type: none"> <li>*In-House teams will be allowed to play 3 games away from their own ice</li> <li>*After 3 games, you have to have an official roster.</li> <li>*(12U and up) 16 minute periods with a 2 minute penalty</li> <li>*(10U and under) 15 minute periods with a 1 ½ minute penalty</li> <li>*Eliminating icing on the penalty kill</li> <li>*12 ice slots vs. 13 ice slots per team</li> </ul>
