The RYSC Financial Aid Program (FA) is open to all players in the club whom payment of registration fees would be a qualified hardship. In order to receive FA, the parent or guardian of the Rec Program player receiving FA must complete **3 verifiable hours of service** to the club, *per player*, during this year. If a player receiving Financial Aid is dropped from RYSC before the Recreation season for their age group ends or the 3 service hours are completed, RYSC reserves the right to deny future registrations of your child(ren) unless all fees waived are paid in a timely manner.

Please fill out and sign the form (“Page 1”) and return it along with a brief description of why FA is being requested and a summary sheet of your 1040 tax form **no later than June 30, 2021.** It can be mailed to the address listed above.

The parent or guardian requesting FA must agree to complete a minimum **3 hours of service** to the club, **per player**, this year. You may serve as a Board Member, a registered Head Coach, Registered Assistant Coach or as a recognized Team Manager to satisfy your service hours. Because repayment of FA through service hours is due to the Club, hours served during “team commitments” other than in those positions listed above, will not be counted. There are other ways to volunteer within RYSC. The rec registrar will email a list of volunteer opportunities to you as soon as your application is approved. RYSC policy is to keep confidential the identities of our FA participants. In most circumstances, only the recipient family, the rec registrar and the Treasurer will be involved in this process. Enclosed is the Verification of Service form (“Page 2”). Please fill it out, sign and return to Vice President when you have completed your service but no later than December 1, 2021. You will receive notification via email if your service hours have been approved.

my child no longer being eligible to play Rec soccer unless all fees are paid in a timely manner. I also

with RYSC.
