Concessions will always run behind at the beginning of the season. Stuff is purchased for tournaments and games and now deposits will start to happen more frequently.

Signage is up from last year. There are still some invoices to follow up on. The committee will begin soon working on signage for next year.

Final registration deposits will be made for next year.

Park and Rec will be a wash in the end to cover ice cost.

Fall Clinic will break even.

Away tournaments will be adjusted as checks are returned for tournaments that we did not get into.

Coach expenses will start to come since no coaches were redlined.

New contracts will be needed for Blades and both high school teams.

Net income = +\$74,000 (Profit/Loss)

Oscar and Melissa met with Paul at Wells Fargo. The recommendation is to move money into investment account that highly conservative (approx. fee to manage 1.75%). OYHA can move it anytime in or out of this account.

Motion made by Oscar to move \$50,000 from investment account into a conservative investment account recommended by Wells Fargo advisor.
