AMATEUR ATHLETIC WAIVER AND RELEASE OF LIABILITY, (Tulsa Sports and Events, Inc.)

- 2) I acknowledge that **I have been provided the following equipment:**
and I further agree to personally inspect this equipment to insure my own safety, to use this equipment safely and responsibly, that it is my sole responsibility to inspect and approve this equipment before use, that I assume all liability for any equipment defects or equipment condition and/or for failure to use the equipment properly including any of my own/borrowed or another's equipment or personal property of any sort, which I may use in the course of participation and hold Tulsa Sports and Events, Inc. and all of their officers, employees, officials, agents and other participants harmless for the same; and,
- 3) I acknowledge and agree that I have been informed herein and that I have been advised by Tulsa Sports and Events, Inc. to safely and carefully stretch thoroughly before and after each event in which I participate AND I acknowledge that I have been advised by Tulsa Sports and Events, Inc. herein to seek qualified medical counsel on the level of my participation in this sport and these events or if I should participate at all and I acknowledge that I have done so and will continue to do so regularly throughout my participation and I freely assume all risk associated with and responsibility for my personal physical, mental and medical condition(s) before, during and after play and hold Tulsa Sports and Events and all of their officers, employees, officials, agents and other participants harmless for the same; and ,
- 4) I acknowledge, understand and agree that Tulsa Sports and Events, Inc; is not liable for any harm to me, my belongings or to others that arises from my use of Municipal/City, County, State, Federal or other Business property including but not limited to fields of play, surrounds, and provided facilities, structures and/or equipment; and,
- 5) I KNOWINGLY and **FREELY** ASSUME ALL SUCH RISKS, Both known and unknown, **EVEN IF ARISING FROM THE NEGLIGENCE OF THE RELEASEES** or others and assume full responsibility for my participation in all events; and,
- 6) I understand and acknowledge that I am signing this waiver with the express intent that it cover all Tulsa Sports And Events, Inc. sponsored or produced games, events, productions and other associations including each and every game date and time in all sports and events in which I participate in any manner, **for 1 year from the date signed below;** and,
- 7) I willingly agree to comply with the stated and customary terms and conditions for participation. If, however, I observe any unusual significant hazard during my presence or participation in any event, I will remove myself from participation and bring such to the attention of the nearest official immediately. **I agree to abide by all rules of play and to cooperate fully and immediately with all instructors.** I agree that if I do not follow the rules, if I do not immediately cooperate fully with all game officials or if I cause intentional harm to another participant, official or to anyone else during any Tulsa Sports and Events, Inc. event I forfeit any and all remaining rights or privileges of participation, all money or other consideration owed by me become immediately forfeit and due in full even if I am refused further participation; and,
- 8) I, for myself and on behalf of my heirs, assigns, personal representatives and next of kin, **HEREBY RELEASE AND HOLD HARMLESS**, Tulsa Sports and Events Inc., their officers, employees, officials, agents, and/or employees, other participants, sponsoring agencies, sponsors, advertisers, and if applicable, owners and lessors of premises used to conduct the event(s) ("RELEASEES"). **WITH RESPECT TO ANY AND ALL INJURY, DISABILITY, DEATH, or loss or damage to person or property, WHETHER ARISING FROM THE NEGLIGENCE OF THE RELEASEES OR OTHERWISE.**
