GFen: Would like to see programs split out and identified.

o P/L and Actual vs. Budget*

BB: "Membership fees" is the total gross membership fees collected. Use the ratio 19:1 take out all the admin expenses and appropriate the balance.

GFen: The intent is to view each program on its own. Today I have to add it up. Are you funding the initiatives, how much? This is a million dollar business let's treat it that way.

PA: I can split this out in 20 minutes. Let me know what you want to see. (was done by GF / PA right there at the meeting)

JB: Who controls PVL?

BB: I do. Not everything was added in yet.

BD: USA has issues on their website for PVL.

BB: We enter that tournament like we enter any other tournament.

GFen: If they don't make the revenue budgeted are we subsidizing them?

BB: PVL is not a professional team. We sponsor them.

JB: We discussed PVL at Adults. It's not an Adult program. Where is their voice being heard? Adults want to be informed about monies being directed to PVL.

GFen: Outdoor (Peter) has been charged to put together a business plan: why isn't PVL required to do that?

LS: (via phone) PVL offers high caliber players to come in and play on a National level. It's turned into a high-level college program providing players the opportunity to be picked up by a European team. It's a good opportunity and I think we should do it. Needs more planning.

PA: I can do a budget, but we don't know how much they need to operate.

GFen: They need revenue.

BB: Tryouts need to start October/November.

KD: Are we growing volleyball? Or funding adult professional players? Need clarification on what the program actually is.

TC: Need marketing and fund raising. Maybe you can get future coaches out of it.

MT: Will this bring in International players to take away the opportunity for our players?

LS: No, International is not allowed.

BB: What do you want to do now?

GFen: Motion to approve the 2016 budget, holding release of funds for PVL and outdoor programing pending an approved business plan by Executive Council. KD sec. (9y- 0n)

GFen: Expense lines will be the same and the revenue will increase, is that right?

GFen: Motion: Approve budget with the membership fee changes as follows: Full memberships from \$55 to \$65, one day \$10.

o Tryout increase at \$15. Increase the background fee from \$17.50 to \$20.

o Add a \$10 fee anytime we need to cancel a limited membership that can't be upgraded in order to register as a full member.
