

Annual Recap:

- Fundraising went very well this year. We raised a total of \$26,007.21 beating our goal of \$25,000 (which was up \$5,000 from last season). Major Events included: Booth at Marinette Heritage & Logging Festival, Daily Pick 3 Raffle (November & February) and Scooter Raffle. Additionally this year we sold candy bars and participated in fundraising partnerships with Buffalo Wild Wings, Schwan's Foods and Amazon Smile.
- Our <u>Concession</u> stand sales were amazing this year. Out Net Profit was \$12,131.14 which beat last year's record by \$167.80! High School Tourney weekend, Pee Wee Tourney and the McDonald Tourney weekends we huge money makers for us. There was continued appealing variety in the concession booth that was very appealing (Coke products, Gummi Worms and Ramen Noodles, etc.)
- > Our <u>Hours</u> Chairperson did a nice job of keeping the spreadsheet up to date and on the website for quick reference.
- > The strong push for our organization to become self-sustaining was the primary focus for the year as evidenced in the mandatory fundraising obligation and/or buyout. As our ice costs again increased this year, so too did our commitment to spend wisely. This increased expense was buffered by a slight rise in our registration fees, which was met by the Association members without complaint as they recognize the necessity of the decision. Even with the increase in ice fees, we were able to have money left in our checking account at the end of the season and did not need to transfer any money from our CD's to cover season costs. This is the first time that has happened in many years.
- > Our Association was awarded State Host for High School for the 2017-2018 season and we have submitted bids to host the following year as well.
- > Our overall balance sheet decreased by \$60,000 this season due to our payment of the first year of our committed pledge agreement towards the building of our new facility. We are \$40,000 away from out total commitment over the next three years which will require continued dedication by our members to achieve while still maintaining a reserve.
- ➤ In the off season, there are several items that will need attention. First, we will NEED a dedicated Fundraising Chairperson and Fundraising Committee. We will need to budget for our \$15,000 commitment towards our pledge this year. Second, we need to look at the Cross Ice program and their fundraising commitments. The alternative fundraising option for that group of selling candy bars seemed well received, so that is a jumping off point for next season. I also believe that as we head into our new facility, every team should host a profitable home tournament. Additionally, we need to implement a solution to the lack of concession stand volunteers during the McDonald Tournament.
- Overall, I learned a lot and very much enjoyed the opportunity to serve our Association and our wonderful children as Thunder Treasurer over the past 4 seasons. Our Association as a whole is on board and aware of our financial situation as we head into our new facility. We have made huge progress over the past 4 years, and that work will need to continue as we work towards fulfilling our pledge towards the new facility. I look forward to another strong year for the Thunder!

I really enjoyed meeting all the families and getting them involved in the program. I feel my presence at each and every practice helped to all the families to feel like they had somewhere to go with their questions.

As always, getting cross ice families involved and willing to volunteer their time was a challenge. I ultimately ended up assigning concession hours for our jamboree as well as the Chummy tournament. We had a decent group of families willing to travel for white games multiple times throughout the season. Our red families were as dedicated as always.

We held a successful jamboree and attended multiple tournaments paid for by corporate sponsorships. Our blue level took home a 2nd place trophy and red took home a 3rd. We were only able to have 2 home games (including the jamboree) due to getting "bumped" and not being able to reschedule with those teams.

Going forward cross ice NEEDS to be allowed home games. The best way to grow the sport and attract young players is for them to be able to watch their friends play. It is going to be hard to get families to stay when they have to travel at minimum an hour (at most 3 hours) just to watch a game, with no option for home games. We also request more than a 45 minute practice. By the time you get 30 some kids on the ice and ready to go, you end up with 30 mins. We have a great group coming in next season to continue growing this level!

Although I will not be Cross Ice Director next season, I am excited to stay active in the association and get back on the board soon.
