

SCFSC Board Meeting Minutes

December 13th, 2016

Reports

- X-Skate numbers
 - o 31 Skaters, 11 High, 19 Low
 - o Possibly some skaters moving up.
- Kim Vaverek is starting to track every month or every other month for skater numbers. Right now we have on average..
 - o Sun AM -14, Monday AM -7, Tues Eve -7, Wed AM -11, Thurs Eve -8, Fri AM -5, Sat AM -9.
- Financials (July 2016- Nov 2016) were discussed. Questions about Misc. columns were talked about to see if they can be more specific. Crista Mrozek made a motion to approve the Financials. A second motion was made by Paula Wavrin and all board members approved.
 - o Checkbook balance \$112,318.71, an estimate of \$35,000.00 still needs to come out of that.
 - o Invoices will go out Quartly now instead of monthly. You can still pay monthly but won't see and invoice every month. We are trying to cut down on some of the Financial Administrator's work.
 - Kaycee, Carol and Crista will meet about past accounts at a later date and make a plan on how to handle those.
- Sonja will run a report for volunteer hours from GCC to confirm everyone has signed in their hours correctly.
- Discussed Marketing/Promo plan (Facebook, Mac TV). Carol Thelen will look into LTS USA for any marketing or ideas for advertising January (National Skating Month).

- Individual Fundraising

Old Business

- Discussed an email Carol Thelen sent out to board members before meeting. Email regarding SportsEngine Online Registration. Maybe looking at replacing PayPal. Kaycee is willing to talk to someone from her end to see how it works on the back side. Maybe start July 1st if it looks like something we want to try.
- Carol Thelen proposed a change in X-Skate Fee's.
 - o Eliminate X-Skate Medium
 - o Keep X-Skate Low at \$140/month 3 sessions of ice/week
 - o Lower X-Skate High to \$180/month -unlimited ice
 - o 2nd family member half
 - o Paula Wavrin made a motion to approve. A second motion was made by Crista Mrozek and all board members approved. This will go in effect January 1st.
 - o Sonja will also add the website (What to do next..)
 - Letting families know how to move up. How to go from LTS to LTS Plus or and go to Freestyle with private coach.
- Raffle Permit has been signed by Kaycee Eiynck. Janelle Honer will follow the next steps and get it sent to the Gambling Control Board of MN.

New Business

- Granit City Classics
 - We had more skaters and those skaters entered more events this year.
 - o Registration will need to make some changes to next year's flow. Crista and Janelle will discuss what needs to be changed before GCC next year.
 - o We will not use a travel agent next year for the judges, it costed extra for each judge.
 - o Will check volunteer list to make sure everyone got credit for their hours.
 - o Got food donated from Quarks Bento Bistro for one meal this year.
 - o Gave back a lot of practice ice this year, seems to be fine.
 - o Another comment was that the rink was really cold this year.
 - At least one club was upset about not doing the team competition this year. Will talk and maybe look into it again next year.

 - Janelle will reach out to others that have showed interest. Janelle will also contact the parents that chaired a position last year to see if they will again.
 - There will be a meeting in January sometime to start getting everything going. An email will go out to the date for whoever is interested.
- Ice Show Guidelines (Specialty numbers- passed Juvenile Freestyle as of GCC, enrolled in X-Skate High).
 - o End of fiscal year the guidelines will be revised.
