### Cash Count and Inventory-Fiscal Year End

### Gambling Audit-MN Department of Revenue

- We received notice that the MN Dept of Revenue completed their audit of the gambling and they determined that no change is needed for the November 2013 through October 2016 MN lawful gambling tax returns.
- Our auditor noted that our records were excellent. It is very unheard of for a charity of this size to not have any changes made to their returns. She also noted that White Bear Lake Hockey Charitable Gambling is the 6<sup>th</sup> largest charitable gambling operation in the state. Based on our numbers it is easy to predict that we should be in the top 2 by the end on 2017.

### Player Appreciation Party

• The player appreciation party was held on February 11th at Doc's Landing. It was a success. We had about 60+ players attend with their families. This event continues to grow each year. We raffled off a 55" TV and gave away 3 large prizes to the players. Food, games and fun was had by all.
