Small Print – Terms, Conditions, Waiver and Health Declaration:

1. I/we have or will secure health insurance to provide adequate coverage for any injury or illnesses that I/we may sustain or experience while participating in the Planet Hockey, Inc. (the "Company") tour and I certify that my/our health coverage will adequately cover me while outside the United States.

2. I/we hereby release and hold harmless the Company, its employees and agents from any responsibility or liability for expenses incurred by me/us for injuries or illnesses (including death) that I/we may incur while on the trip.

3. I/we warrant to the Company that I am/we are ready, willing, and able to physically and mentally participate in this trip. I/we knowingly and voluntarily assume each risk related in any way to my/our participation. I/we understand there is, without limitation, no life, health care, or other insurance provided for me/us by the Company which would cover my/our death, or health care or other expense arising out of any injury or illnesses that I/we might sustain resultant from my/our participation in this trip. I/we accept responsibility to pay and be responsible for all expenses arising out of injury or death myself/ourselves and/or, due to my/our act(s) or omission(s), to any other person/entity. I/we acknowledge I/we have sole responsibility for loss or damage caused to or by my/our personal property used in/for the trip.

4. I/we understand that there are unavoidable and unforeseeable risks in travel abroad. These risks include, but are not limited to, criminal activity, war, terrorism, public health risks, transportation risks, property loss or damage, physical or emotional injury, and death. I/we acknowledge that I/we have independently reviewed and assessed said risks. Knowing these risks, and in consideration of being permitted to participate in the Company's trips, I agree, on behalf of myself, my family, heirs, and personal representative(s) to assume all the risks and responsibilities surrounding my/our participation in the Company's trip. To the maximum extent permitted by the law, I/we release, hold harmless and indemnify the Company, its employees and agents, from and against any present or future claims, loss, or liability for injury to person or property, which I/we may suffer, or for which I/we may be liable to any other person or entity, during my/our participation in the Company's trip (including periods in transits to or from the country where the tour is being held).

5. No refund is possible for any person starting but not completing the tour. Uncompleted portions of the tour itinerary are not cause for refund. No refunds for cancellations after April 1, 2018.

6. Payments: All tour participants are to be paid in full by June 1, 2018. A late payment fee of \$50 per participant may be assessed. The Company reserves the right to cancel participation of any participant who is not paid in full by June 1, 2018 and all paid monies collected to date will be forfeited.

7. The Company does not provide any level of protection coverage on tour participants. Tour members assume any and all risks inherent in European travel.

8. The Company strongly encourages all tour members to consider purchasing insurance to cover the following risks while on a tour: medical, surgical and dental; additional expenses; baggage; loss of money; personal accident and personal liability.

9. Our itinerary is subject to change. European tours are full of surprises and all participants need to be flexible and adapt to changes so that we may provide the best possible tour. I hereby release, waive, discharge the Company, its employees and agents (hereinafter referred to as "releasees") from any and all liability, claims, demands, actions and causes of action whatsoever arising out of or relating to any loss, damage or injury, including death, that may be sustained by me, or to any property belonging to me, while participating in this European tour. I voluntarily assume full responsibility for any risks of loss, property damage or personal injury, including death that may be sustained by me, or any loss or damage to property owned by me, as a result of my traveling to the destination described above. I further hereby agree to indemnify and save and hold harmless the releasees and each of them, from any loss, liability, damage or costs they may incur during my travels. It is my express intent that this Release shall bind the members of my family and spouse, if I am alive, and my heirs, assigns and personal representative, if I am deceased, and shall be deemed as a release, waiver, discharge and covenant not to sue the above named releasees.

10. Participation: Our commitment is to provide a professional travel experience to all participants. In the unlikely event that a tour participant (player or family member) behaves in a way that is incompatible with the safety and convenience of others and/or deemed by the Company to be inconsistent with acceptable behavior, you agree that in those circumstances, the Company has the exclusive right and discretion, to expel said participant immediately and at said participant's expense, without any claims or complaints by said participant against the Company.

11. Physical Condition: Our tours are physically demanding. To enjoy the experience, you must be in good physical shape. Most days involve extensive walking (often over uneven paving stones), walking and stair-climbing.

12. Disabilities: Any pre-existing physical, mental, or emotional disability that may require attention or treatment must be reported in writing prior to the beginning of a tour.

13. Tours/activities/events cancelled by the Company: Although unlikely, a tour/activity/event may be cancelled and/or rescheduled due to unforeseen circumstances. If the Company cancels an event/activity you have paid for, the entire amount you have paid to the Company will be refunded to you within thirty days after the event/activity cancellation. Once this occurs, the Company and its representatives have no other obligations to tour members.

14. I certify that my agreement to the provisions herein is voluntary and that, prior to signing of this waiver I have the right to consult an advisor or attorney of my choice.

15. I certify that I have read and that I fully understand this Travel Waiver.

16. I certify that I am at least eighteen years of age or, if not, that I have secured below the signature of my parent or guardian as well as my own.
