### **Open Forum:**

CJ Woodrow presented the Pitch2Pitch fall league. The program is designed for players 10 thru 15, and will consist of practices sessions and high level competition in a training environment. A number of other communities are also interested and leagues may be restricted to 6 teams. Post season play will be available. Pricing is estimated at \$75.00 per player. OMGAA would be allowed to set up concessions. Teams may register as part of an association or as individual teams. OMGAA would sponsor teams to meet the city insurance requirements.

#### Parks and Recreation Report:

Chris Morrow reported that Katie will be returning to work in May. Coaches can start reserving fields at the end of April. Fields need a little time in the early spring to re-establish roots.

## Secretary's Report:

Planning an "On Field" training event with Pitch2Pitch, costs will be covered by the training budget.

Items still open for T/D – updating on line information, developing programs with partners such as P2P, Acceleration & Stack, and working with MYAS on a coaches certification program.

<u>10/12 League:</u> Greg reported his numbers are up a little, but that may be due to pulling 12 year olds back in. Several "Storm" drop downs withdrew. Working on schedules, will be completed soon. Introduce Donna Olson to be OMGAA Social Media Coordinator (will be discussed under new business).

<u>8/9 year old league:</u> Aric reported that numbers are down, thinks we lost 4 teams to Corcoran because of pitching age levels. He feels they will be back next year. Schedules are done and coaches are in place.
