- A. Letter to USA Hockey re: women's/girls rule change was sent out by S. Jacobsen to the women's and adult's USA Hockey representative, and cc'ed to MAHA Women's/Girl's Coordinator Jean Laxton.
- B. Results of NTDP survey re: honoring military, police officer, firefighters were discussed and will be submitted to Jean Laxton with MAHA for recognition. The league members who responded and were open to being recognized for their service were Heather Morrison (Bombshells former military & police), Chelsea Slater (Epcot Ducks former military), Jillian Wallace-Hall (Predators former military), Jennifer Symons (Swarm former police officer), Fran Brady (Rampage former military).

IV. New Business

- A. Division 1 updates (T. Callahan/S. Parker)
 - 1. No complaints have been been formally filed, but the Board is concerned with the lopsided scores that have been submitted by the Outlaws since the split of the teams into upper D1a and lower D1b.
- B. Division 2 updates (S. Martin): No issues to report.
- C. Division 3 updates (S. Krug-Shaffer absent)
 - S. Krug-Shaffer is working on entering a backlog of scoresheets. Several
 outstanding/missing scoresheets are still needed from Polar Bears and TOT FU.

D. Division 4 updates

- 1. Kelliey Unsworth-Gamicchia was released from D5 Cleavers to D4 Ice Ninjas.
- 2. Discussion re: Referee exclusion of Bianca Bartolomei, Kim Gallagher in D4. The idea of creating an exclusionary list of referees to give to the referee scheduling manager (in the interest of avoiding conflicts of interest) was brought up. The purpose would be to avoid any further instances of referees working games in a division with which they are affiliated. Bianca and Kim attended the meeting in order to shed some light on how/why they were scheduled in D4 (a division in which they are coaches). Currently, there is no system in place that allows the referee scheduler to know in what division he/she is placing the referees. S. Jacobsen will send an email to all the D4 managers explaining the rule in question and let them know that the Board has decided that it will not allow Bianca and Kim referee in D4 the remainder of this season in order to avoid any perceived bias. If necessary, this officiating exclusion rule in the handbook (p.24) will be open to discussion and/or change over the summer.

- 1. Brenda Adams' player appeal to move from D4 Storm to D5 Cleavers was submitted on 12/19/16. Appeal was reviewed and approved via email 6-0 (1 abstained).
