Stacey-Tournaments

Provided breakdown of estimated costs/profits for hosting tournaments in upcoming season (see 5/15/email attachment for details). Looked at costs other associations are charging in metro area, averaging \$1050 for local tournaments. Assuming we sold out could charge approximately \$400 to draw even. If charged \$800/team, would make approximately \$3,100 + \$1400 (home teams fee savings) = \$4400 per tournament.

Need returning numbers prior to deciding what levels we would host

Need tentative dates for negotiation with County on ice & need to adjust amount of hours we book, specifically on Sat/Sun. Past tourneys county sold us 11.5 hours each day. Only need a little over half of those hours on weekend. Stacey will look at needed ice times for weekend in more detail to report out actual #.
