Possible Board consideration for "at-large" bids to pay a portion or if the team didn't get to participate in their 2 tournaments.
- Discuss IGHBA handling the management/organization for VFW/Legion level teams Managed and scheduled by IGHBA. High school coaches will have a say and will coach.
- Discuss possibility of merging Simley Baseball Booster Club into IGHBA IGHBA take over Booster club and would then support 9-High School with a fluid transition
