



# 2017 DCFL Fall League Guidelines

**Registration Due: August 14, 2017 @ 7pm**

Season: August 22 - October 24, 2017

## **Team Registration**

- Team registration fee is \$750, **open to any Michigan resident** 18+ years old
- Teams are co-ed; 3 members of the minority sex must be on-field to compete as a full team
- Games are scheduled to be played at Historic Fort Wayne (6325 W. Jefferson Ave.)
- Each team **must be affiliated with a bar** (bar representative signs off); bar will be your team name
- Team captains are encouraged to organize matching jerseys for their team

## **Schedule & League Rules**

- Games will be played Tuesdays & Thursdays at the following times during the following date ranges:  
**Aug 22 through 31 @ 6:15pm & 7:15pm | Sept 5 through Oct 5 @ 6:15pm | Oct 10 through 24 @ 6pm**
- Arrive to the field 15 minutes prior to your game start time.
- Regular season format: 2 halves of 25-min with a 5-min halftime. No overtime. Win: 3 pts; Tie: 1 pt
- Playoff format: 2 halves of 15-min with a 5-min intermission. Kicks from the Penalty Mark will occur if game is tied after regulation (best of 3; followed by single rounds).
- Each team selects a captain to enforce rules with his/her team and ensure players sign waivers.

## **Recreational Nature of League**

- **Have fun. Don't be a jerk.**
- Players are expected to be courteous and conduct themselves appropriately.
- 'You kick it you get it.' The player that kicks the ball past a goal line is responsible for its retrieval.
- Each team supplies a size 5 game ball to be approved by the official and opposing team.
- Captains and game officials meet before the match to review rules and verify team rosters.
- Game officials may issue yellow and/or red cards. Ejections may occur via referees or DCFL staff in cases of unsportsmanlike conduct. Excessive physical play may result in a ban from future play.
- A field player cannot challenge a goalkeeper who has or pursues possession within the box.

## **All FIFA rules apply except...**

- Size of the goals are reduced to approximately 6.5ft by 18ft.
- Field size is reduced from to approximately 160ft by 240ft.
- Games are 8v8. Teams will field 7 players + 1 goalkeeper (different colored shirt required)
  - Each team must have 3 members of both sexes on the field during play. See attached co-ed sheet for explanation.
- Goalkeepers are not permitted to punt or drop kick the ball, or throw the ball past midfield.
- Penalty kicks will be taken 10 yards from the goal.
- Off-sides is not enforced. There will only be direct kicks (no indirect kicks).
- Unlimited substitutions are permitted from midfield during stoppages or goalkeeper possession.
- Cleats and shin guards are encouraged but not mandatory.

*All players must sign the DCFL liability waiver. Only players listed on the waiver will be included on your team's roster. All waivers and fees are **due August 14, 2017**. Please provide **one check per team, made out to "Detroit City Futbol League."** Checks made out to Detroit City FC will not be accepted.*

### ASSUMPTION OF RISK, HOLD HARMLESS, AND INDEMNITY AGREEMENT

In consideration of being permitted to participate in the activities of Detroit City Futbol, I, on behalf of myself and my heirs, represent, warrant, and agree to the following:

1. I do not have any health-related conditions, disabilities, etc., that would restrict my participation in Detroit City Futbol activities.
2. I understand the risks of participating in Detroit City Futbol activities and that participation in Detroit City Futbol activities can result in bodily injuries or even death. I hereby accept and assume the risk of and full responsibility for any loss, property damage, personal injury or death, which may be sustained as a result of my participation and involvement in Detroit City Futbol activities.
3. I have read and understand the Rules and Regulations provided by Detroit City Futbol and agree to abide by them.
4. I agree to hold harmless and indemnify Detroit City Futbol, its organizers, captains, volunteers, sponsors, and all participants (hereafter collectively referred to as "Detroit City Futbol") from any and all claims, actions, losses, costs, expenses, damages, and liabilities, including actual attorneys' fees and related costs, that may be incurred as a result of my participation in Detroit City Futbol activities. It is my intent that Detroit City Futbol shall not be liable for any damage, loss or injury to me in any way connected to my participation in Detroit City Futbol activities and I hereby release and discharge Detroit City Futbol from any liability for damage, loss or injury to me in any way connected to my participation in Detroit City Futbol activities.
5. I acknowledge and agree that my relationship and involvement with Detroit City Futbol does not create a bailment and that Detroit City Futbol is not responsible for any items that are lost, stolen, or damaged.
6. I AGREE TO WAIVE THE RIGHT TO A TRIAL BY JURY OF ANY MATTERS ARISING OUT OF OR IN ANY WAY CONNECTED TO MY PARTICIPATION IN DETROIT CITY FUTBOL ACTIVITIES.
7. This Assumption of Risk, Hold Harmless, and Indemnity Agreement (hereafter "Agreement") shall be construed and interpreted pursuant to the laws of the State of Michigan, and if any portion thereof is held invalid, I request the remainder continue in full force and effect.
8. I understand this Agreement is the final, complete, and entire agreement between Detroit City Futbol and me. All prior or contemporaneous written and oral statements, negotiations, representations, agreements, and warranties related to or pertaining to this Agreement are superseded and merged into this Agreement.

<p style="text-align: center;">PLAYING REDUCED</p>  <p>2 of minority sex are on field No more than 5 of majority sex may be on field Team plays with 7 players</p>	<p style="text-align: center;">PLAYING REDUCED</p>  <p>1 of minority sex is on field No more than 5 of majority sex may be on field Team plays with 6 players</p>
<p style="text-align: center;">FORFEIT</p>  <p>0 of minority sex are on field Team forfeits.</p>	<p>In case of forfeit, the game may still be played if both captains desire, but there will be no score reported and no referee.</p> <p>The referee is still paid regardless of whether game is played.</p>
