

RNC ATHLETE PARTICIPATION WAIVER AND RELEASE OF LIABILITY

In consideration of being allowed to participate in a Rugby NorCal (hereby known as RNC, Inc.) youth or high school rugby season and/or related events and activities, the undersigned:

1. Acknowledges and fully understands that each participant must be fully and properly registered, ID verified and uploaded in the MatchApt (by AdeptSoft) system and that all required waivers have been signed during the registration process and verification available to RNC, Inc. before participating with any RNC, Inc. member team or club; and
2. Acknowledges and fully understands that each participant will be engaging in activities that involve risk of serious injury, including permanent disability and death, and severe social and economic losses might result not only from their own actions, inactions, or negligence, but also the action, inaction or negligence of others, the rules of play, or the condition of the premises or of any equipment used; and
3. Assumes all the foregoing risks and accepts personal responsibility for the damages that may follow such injury, including permanent disability or death; and
4. Releases, waives, discharges and covenants not to sue RNC, Inc., its affiliated clubs, their respective administrators, directors, agents, coaches, and other employees including Athletic Trainers, Referees, or volunteers of the organization, other participants, sponsoring agencies, sponsors, advertisers, and if applicable, owners and/or leasees of premises used to conduct the event, all of which are hereafter referred to as "Releasees," from any and all liability to each of the undersigned, his or her heirs and next---of---kin for any and all claims, demands, losses or damages on account of injury, including death or damage to property, caused or alleged to be caused in whole or in part by the negligence of the Releasees or otherwise.

Further, consent is hereby granted to RNC, Inc., its Athletic Trainers, Emergency Medical Technicians (EMT's) and its member clubs and teams to initiate any medical or first aid treatment for the undersigned participant in the event of a significant injury or illness. The undersigned understands that a reasonable attempt to locate a parent and/or guardian of the participant will be made in the most expeditious manner possible. In the event a parent and/or guardian cannot be reached, the undersigned understands that any treatment necessary for the best interest of the participant may be initiated.
