



LOON RACE TEAM RACER FINANCIAL AID APPLICATION

The purpose of the LRT Racer Financial Aid program is to allow a racer the ability to be an LRT athlete who would have otherwise been unable to do so due to financial reasons. Financial Aid Awards will be determined once the following three steps are completed: First, completing this form named the Racer Financial Aid Application. Second, completing the Parent Financial Aid Statement. Third, the racer's completing the 4 essay questions given below. The family's history with and commitment to the LRT will also be considered.

The LRT Racer Financial Aid program is available to Rut Riders – U19 athletes who are racing (excludes Training only option). A racer may be awarded up to 75% of all tuition fees for LRT. Priority for the awarding of financial aid is as follows: 1) Lincoln and Woodstock Residents; 2) State of New Hampshire and Massachusetts Residents; 3) Other State Residents. Race work is required by all racer Parents. Buyout for such a requirement is not permitted for those receiving LRT Racer Financial Aid.
