season, OHC's USA Hockey Number for 13-14U team. For 208-2019, they will not be allowed to use our number and in order to obtain their own USA Hockey number they must form a 505-B and Establish a Board of Directors, etc.

To combat the formation of the 12U Team this season, proposed registration fee per team is \$1500.00 (for 5 Teams) which will either kill the 12U formation or, will generate additional revenue for OHC.
