#### President's Report: Eric Anderson

- Verbal agreement with Director of Coaching; contract hopefully signed soon.
- Official announcement of shirts sponsorship will be Aug. 1 or soon after that date.
- Request from a family to reconsider competitive daytime practices in August, as it can be challenging for parents who both work outside the home. Background: The reason for that schedule is maximizing opportunities due to the kids not being in school; four

practices per week gives kids a chance to attend some or all, depending on their schedules; some families are on vacation in August. If we switched to the format used in fall/spring, field limitations would mean only two practices per week per pool, plus one combined session on Fridays.

- Paula and I are working on registering the remaining people. Goal is to be finished by Aug. 1. This takes some time with people in vacation, late fees on some, payment plans and some people just being challenging.
