**Entries:**     We allow an unlimited number of runners to participate in each of the races, however, only the first SEVEN finishers from each school will count for team scoring. Varsity runners do not need to be declared. The top seven finishers from your team will automatically become the varsity for the purpose of team scoring.

**Rosters:**     Must be emailed to the Wisconsin Runner at [wisrun@gmail.com](mailto:wisrun@gmail.com). They must be submitted on the downloadable excel xc roster form on the Wisconsin Runner homepage [www.wisconsinrunner.com](http://www.wisconsinrunner.com). Simply download the form, save the form and then email it. Rosters are due by 8:00 Pm on Monday, September 26<sup>th</sup>. It is not necessary to specify Varsity or JV; additions or corrections may be made on race day. If you have any problems, please contact the Wisconsin Runner at (262) 633-0033. Teams that submit their rosters after the deadline will be assessed a **\$25.00 late** fee. Send a current roster even if you have run in a meet that Wisconsin Runner scored this year. Do not convert the Excel file to a pdf.

\*\* Coaches please pick up a team packet in the shed when you arrive at the course on Thursday, September 28<sup>th</sup>. At that time please make any additions or subtractions.

**Parking:**     Please park in the UW-Parkside lots east of the course. Teams and spectators may not park in any Petrifying Springs lots! County Sheriffs Ticket violators.
