Educating my coaches, parents, players, administrators and anyone else participating in my club in the SafeSport policies in my club; and 3. REQUIRING complete compliance of all such policies by club participants.
	4. I agree to fulfill ALL personal and club financial obligations to the Arizona Region by the deadlines provided. Late fees may be assessed for late payments.
	5. I understand that the Arizona Region strongly discourages club directors or coaches contacting potential club members or their parents in a way that distracts them from their school team responsibilities and participation. As such I agree that there will be no club initiated contact by me, my coaches or any other club representatives (including players and parents) with junior volleyball players or potential club members and their parents a minimum of 8 hours prior to and for the duration of a practice, match or tournament during the school season AND once a player has committed to a club through the last day of the Jr National Championships and High Performance Championships (if applicable). Contact during this time frame is a violation of Arizona Region recruiting policies and may be cause for sanctions imposed by the Ethics & Compliance Officer and the Board of Directors.
	6. I understand that USAV and AZ Region policy states that all players are committed to the club they sign with for the season until: 1. the end of the Jr National Championships (regardless of when they finish Region play) or 2. are released by the club.
	7. I agree that I will not allow anyone from my club to invite or offer player(s) committed to another club the opportunity to play in any type of post-season activity, without the consent or release from the player's club director first.
	8. I agree that I will not make any financial arrangements for or other offers to a potential or current club member that could possibly jeopardize their AIA, NCAA or Arizona Region eligibility. It is the responsibility of the club to educate their players and parents regarding eligibility and unethical offers and enticements that could jeopardize their eligibility.
	9. I agree that I will not make negative or intentionally false comments concerning school coaches, other clubs, or their staff to current or potential players, parents and coaches and will instruct my coaches and staff to refrain from the same.
	10. I agree that I will not ask or allow any player to commit to my club (verbally or in writing) before they are allowed to per Arizona Region policy or if they are committed to another club.
