The event will not be cancelled or rescheduled for any reason. Teams should make every attempt to participate in the event.

Take 94West to exit North 164 & South J #294. Exit North 164 & South J and turn left (South). Proceed to the 3<sup>rd</sup> light, Northview Rd (FT). Turn right (West) on to Northview Rd. Proceed approximately ¼ mile, and facility is on your left (South side). Park in the lot or on the street. Entrance is in the rear.

## **Important Facts:**

- 1. Coaches must sign off on acceptable Webpoint roster before competing in any matches on the day of event.
  - a. Coaches on roster must have IMPACT or higher education and be safe sport certified
  - b. Team fee paid yes or green check mark top right corner
- 2. Teams that have not turned in their <u>Webpoint roster</u> for their team will not be eligible to participate. (NO EXCEPTION!)

  Please present your roster at the tournament table upon arrival to the facility. No teams will be able to participate until the Webpoint roster has been signed by coach or other staff personnel listed on the roster. Thank you.
- 3. There will not be a coaches meeting, any changes will be provided to you when checking in that morning and signing the acceptable Webpoint roster.
- 4. No food may be brought into the facility. Any coolers must be kept in the car.
- 5. Concessions will be provided by the facility.
- 6. No gum, food, or beverages (other than water) will be allowed in the gym.
- 7. Gym bags should be placed on the bleachers or off to the side walls. (DO NOT STORE AT BENCHES!)
- 8. Neither Center Court nor the Midwest Penguins are responsible for lost or stolen items.
- 9. Region up referees have been requested and will be provided for all matches, based on availability within the Region.
- 10. Please start the warm-up time immediately following the conclusion of the previous match. This is extremely important, so that we may stay on schedule, get all the matches in, and all leave at a reasonable hour!!! Please work together.
- 11. Teams must provide a down official (R2), scorekeeper, libero tracker, & 2 lines judges for pool play. (Note: When a 5 team pool is scheduled, then teams will cover both courts, R1 duties will be provided.).
- 12. Admission will be \$5.00 per person at the door.
- 13. Penguin's and Center Court first aid will consist of band-aids and other basics. (Ice is available as needed in concession area.)

**Rules:** USA Volleyball rules will be utilized. There will be a tournament directors table set up in the facility. We ask that teams that have officiating duties bring the completed score sheets to that table before the start of warm-ups for the next match.

**Warm-Ups:** Team warm-ups will consist of 2-4-4 prior to their first match of play (2 shared ball handling, then 4 of each team having their court time which includes serving). All subsequent matches will consist of 3-3 (each team will have to serve within the 3 minutes.). The team NOT warming up, WILL stand behind end line and assist opponent with shagging balls with good sportsmanship. The first match of the day will start on time. All matches that follow may run ahead of schedule. It is the responsibility of each team to follow the progress on their next assigned court and be ready to play when the court is available.

**Format:** Matches will consist of best of 3, unless otherwise noted on schedules. The first two games rally scored to 25 points and the third if necessary rally scored to 15 points. All games are win- by 2, no cap. The event is scheduled to conclude by or near 5:00 pm. If the pool of teams in any division is large, or many playoff games are necessary, the early rounds of playoffs may consist of a single game to 15 or 25. The site director will determine whether playoff rounds will be condensed based on the time playoffs will start and considering how many rounds of playoff will be required.

**Tie Breakers:** There will not be any tie breakers. Rather, crossover seed/position assignments shall be determined by the following. If 2 teams are tied, higher seed will go to the winner of head-to-head.

If 3 teams are tied, all three teams will be ranked by the following criteria in order: GAME WINNING % (Games won divided by games played), then TOTAL POINT DIFFERENTIAL (Total # of points won subtracted from total # of points lost), then COIN FLIP.

This process, should allow all the teams to have a minimum of 4 matches, and end the day at a reasonable hour. Any questions, please ask the site directors.

# SPECTATOR/PARENT CODE OF CONDUCT

(This legally binding document may be reproduced as often as necessary)

IMPORTANT NOTICE – ENTRY TO THIS PRIVATELY SANCTIONED EVENT IS GRANTED AS A COURTESY. IF YOU ENTER/ATTEND THIS, OR ANY BADGER REGION SANCTIONED EVENT, YOU AGREE TO ABIDE BY THE FOLLOWING CODE OF CONDUCT GUIDELINES:

#### I WILL:

- 1. I WILL abide by the official rules of USA Volleyball.
- 2. I WILL display good sportsmanship at all times.
- 3. I WILL encourage my child and his/her team, regardless of the outcome on the court.
- 4. I WILL educate myself on the unique rules of this facility.
- 5. I WILL honor the rules of the host and the host facility.
- 6. I WILL generate goodwill by being polite and respectful to those around me at this event.
- 7. I WILL direct my child to speak directly with his/her coach when coaching decisions are made that may be confusing or unclear.
- 8. I WILL redirect any negative comments from others to the respective Event Director or Program Administrator.
- 9. I WILL immediately notify the Event Director and/or Program Administrator in the event that I witness any illegal activity.
- 10. I WILL support the policies and guidelines of the team/club that I represent.
- 11. I WILL acknowledge effort and good performance, remembering that all of the players in this event are amateur athletes.
- 12. I WILL model exemplary spectator behavior while attending this event.
- 13. I WILL respect the history and tradition of the sport of volleyball by being a good ambassador.

### I WILL NOT:

- 1. I WILL NOT harass or intimidate the officials.
- 2. I WILL NOT coach my child from the bleachers and/or sidelines.
- 3. I WILL NOT criticize my child's coach or his/her teammates.
- 4. I WILL NOT participate in any game or game-like activities unless I have a current membership card with the Badger Region.
- 5. I WILL NOT bring and/or carry any firearms at any Badger Region event.
- 6. I WILL NOT bring, purchase, or consume alcohol at any Youth/Junior volleyball event.

Note: Any violation of this Code of Conduct will result in you being asked to leave the site/facility, and may result in you possibly being banned from attending future Badger Region sanctioned events. The Event Director has the final say regarding their individual event. Local law enforcement will be contacted if necessary to resolve any disputes or altercations. Questions or concerns may be directed to the Badger Region office.
